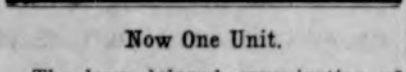

Now One Unit.

The long delayed organization of people in the Inland Empire has grown out of the Tuesday meeting at Lewiston and the night session at Walla Walla when a new Inland Empire Waterways association was formed to unite the efforts of groups in eastern Oregon, eastern Washington and Idaho, in securing sea locks at Bonneville. The people representing this territory are quoted as being "1,094,329," who, by directed effort, should be able to carry some weight in securing the attention of representatives at Washington and metropolitan centers.

Following this important step of forming organized forces of mutual interests, the old domination of forces in better represented sections should be eliminated. The feeble struggle of groups in isolated sections will now be united in one effort in the request for the construction of sea locks at Bonneville. These people of the interior represent the 75,000,000 or more bushels of grain grown annually to be shipped out to logical markets. At present, and for years, these rates have been preposterous, and yet the farmer has been unable to do anything about it.

At present the major project under consideration is the construction of adequate locks at Bonneville but there are many other regional matters with which an interior federation may deal. Every county every municipality, commercial club, cooperative and every important business establishment can not help but realize the necessity of sustaining such an organization because of its scope and influence above that of sectional effort.

This is not a matter at which shoulders should be shrugged, and all considerations dismissed, but every shoulder should be put to the wheel and start it rolling under proper leadership, along legitimate lines.

Prominent Portland daily papers have previously asked the people in eastern Oregon and western Washington to "sit tight" and not buck the construction of inadequate locks at Bonneville due to the danger of delaying the construction of the authorized dam, but it is not a matter of opposition but of sound judgment.

It is true that "a territory that has 1,094,329 people within its borders should have an organization on a par with the size of the territory and the importance of its economic problems."
