### The Oregon Basic Science Law.

The Oregon Basic Science Law which was passed by the last state legislature to become effective January 1, 1934, is being contested by the Healing Arts Amendment and will be referred to the voters at the May primary election.

The law requires all doctors of all schools of healing who propose to care for the sick in Oregon to first pass an examination in the basic fundamental studies or sciences. And it is reasonable to assume that no matter how widely nor how differently one may interpret the facts, no matter how far apart may be the theories in regard to the alleviation of suffering, no one should be permitted to receive the license of the state to practice as a physician unless he gives evidence of a reasonable knowledge of such subjects as anatomy, human pathology, physiology, chemistry, hygiene and other similar sciences, which do not reach theories but fundamental facts.

As a means of protection for public health it seems only reasonable that anyone applying for a license to practice in the state of Oregon should have a basic knowledge of these five above named sciences. The law requires that an applicant to take the examination must have a

high school education, be 21 years of age or over, and be of good moral character. The examination, as we understand it, is not unduly severe but is such as to determine that the applicant has a reasonable knowledge of the elementary principles of the fundamental subjects underlying the healing art.

The Basic Science Law is effective in seven states in the union at the present time. It does not effect any person now practicing the healing arts who has a license and an established following, but applies to new applications for licenses.

### INVISIBLE MAN INGENUOUS

#### BIT OF FILM WORK

In "The Invisible Man," which will play at the Oasis theatre Sunday and Monday, the Universal studio has brought to the screen one of the outstanding novelties of the season, in which a highly imaginative story is enlivened with much ingenious photography.

The story hinges on a scientist's discovery of a drug concoction which makes flesh and bone invisible, but which, unfortunately, also affects the mind and makes him a murderous maniac with an obsession for world power.

Subsequent developments recall a couplet from Robert Louis Stevenson's pleasant little poem to the wind:

I saw the different things you did,  
 But always you yourself you hid.

Clothed and swathed in bandages, the invisible man is able to appear with an indication of human substance, but the film reaches the height of the grotesque when he unwraps the bandages and reveals thereunder nothing but space.

The audience at the opening show found the picture, in the main, highly amusing, but it was impossible to escape the suspicion that more mirth was indicated than the producers intended. The horror angles of the story give viewers the uncomfortable feeling of finding themselves at murder.

Claud Rains, in the invisible role, reveals a voice and manner of speaking hardly to be distinguished from that of Alan Mowbray, whose diction is among the screen's best. Mr. Rains has excellent support in Gloria Stuart, who shares the brief love-interest, William Harrigan and Henry Travers. The others are incidental.

### LAUGHTON HAS FINE SUPPORT

#### IN PORTRAYAL OF HENRY VIII

When the United Artists corporation some months ago announced a forthcoming appearance of Charles Laughton in "The Private Life of Henry VIII," the proposal was hailed as a "natural"—a rare combination of a remarkable actor in just the right role to bring out the best of his talent and result in an unusually enjoyable performance.

The forecasters were right, Charles Laughton has won the award of the Motion Picture Academy of Arts for the best performance of the season in this picture, which shows at the Oasis theatre Friday and Saturday.

Mr. Laughton has given the screen many memorable character portrayals—the murdered in "Payment Deferred," the jealous-mad submarine commander in "Devil and the Deep," the fanatic scientist in "Island of Lost Souls," the oppressed clerk in "If I Had a Million," and Nero in "Sign of the Cross," but his Henry VIII eclipses all the others.

The film offers much of interest in lifting the veil from the face of history and portraying with apparent authenticity the manners of the 16th century, but it is Mr. Laughton's performance in the central role that is important.

The high point of humor is reached in a scene in which the German duchess of Cleves, in love with a man of her own choice, makes herself as unattractive as possible on the night of her marriage to Henry, and plays cards with him on the royal bed to win his jewels, much money, and her freedom. By way of dramatic contrast is Henry's grief at the execution of his fifth wife, whom he really loved.
