## STANFIELD BOY SCOUT TROOP NUMBER 55 INSTALLED WED. NIGHT

### W. A. NASSHAHN NAMED TROOP SCOUT MASTER.

Eight Members of Newest Troop in Blue Mountain Council Presented With Charter.

At an impressive service in the Stanfield high school auditorium Wednesday night, Boy Scout Troop 55 of the Blue Mountain Council was installed, with Troop 55 of Hermiston and Troop 58 of Umatilla present. W. A. Nasshahn, athletic coach of Stanfield high school, is acting as the new scout master, and the following boys were presented with the charter: Raymond Meade, Jack Meyer, Robert Gibson, Frank Thorne, Russel Lay, Robert Refvem, Willie Gossage and Cecil Brown. R. F. Refvem is chairman of the troop committee, and other members of the committee are Roy Penney, C. M. McCall, Jess Gossage and John Heckman. The Commercial club of Stanfield is sponsoring the troop. Robert R. Hayes, scout executive of Walla Walla, presided at the installation service. It was made very impressive with candle light service and a ring formed by the visiting scouts. Mr. Hayes gave a short talk on the true meaning of being a scout and what was expected of them. Oscar Payne, scoutmaster of Hermiston, then made a few remarks in which he pointed especially to the responsibilities of the parent and business man of the community.

H. A. Pankow also instructed the new troop committee. He stressed the importance of one member at least being present at every meeting of the troop, and helping the scoutmaster with his work. A court of honor presented the following awards: Paul Marble, first class scout, Hermiston, successfully demonstrated how to bandage a broken arm, and was awarded the first aid badge; Ralph Marble, Hermiston, was given ranking as second class scout; L. Root and Ralph Davis of Umatilla passed the requirements for the life saving badge; L. Root was also given the scholarship award; Vivian Brown and Harold Reeves of Umatilla were given ranking as star scouts, having earned five merit badges after becoming first class scouts. The Umatilla bugle corps presented a brief concert to those present, and after a few interesting contests between the troops, refreshments were served to all present.

## BOWMAN FACES MURDER CHARGE IN FRED LAMPKIN KILLING

An information charging Dan Bowman with second degree murder in connection with the killing of the late Fred W. Lampkin, has been filed at La Grande, states Carl Helm, district attorney of Union county, who was in Pendleton Wednesday.

Fred W. Lampkin, co-publisher of the business manager of the Pendleton East Oregonian, was the victim of a shot from a gun in the hands of Dan Bowman during a heated argument over some pictures that Finis Kirkpatrick had taken of Mr. Bowman a short time before, according to Charles Goodyear, one of the members of the hunting party composed of Mr. Lampkin, Finis Kirkpatrick, Roy Hobby and himself. The shooting occurred at Sheep Camp, about 13 miles south of Starkey, at noon Friday, November 9.

A preliminary hearing was held (Thursday) afternoon in La Grande.

No Bail.

As is customary in murder cases no bail will be admitted and Bowman will be removed from the hospital to the county jail as soon as his condition permits. His right leg is in a cast, the result of a torn ligament he suffered at the elk hunting camp the morning before the shooting, which Bowman asserted was accidental. Testimony at a coroner's inquest, however, did not corroborate Bowman's story.

Funeral services for Mr. Lampkin were held from the Folsom Chapel Tuesday, November 13, at 2:30 p. m. with Dean Ralph V. Hinkle, rector of the church of the Redeemer, conducting the service.

### IRRIGATION DIST. DIRECTORS NAMED AT ELECTION TUESDAY

One director to serve for a three year term was elected Tuesday on each board in four irrigation districts in the west end of Umatilla county.

Wm. Haggman, with 31 votes, was named director for the Stanfield district, against H. V. McCormick, with 28 votes. In the Westland Irrigation district J. M. Prindle received 21 votes and A. D. Smith 7 votes. E. L. Jackson was unanimously elected in the Hermiston district. At Irrigon, in the West Extension Irrigation District, A. E. McFarland received 66 votes and Pearl Jarvis 25 votes.

### Fined for Reckless Driving.

John Williamson of Heppner was arraigned before Justice P. P. Sullivan Friday afternoon, October 9, and fined \$25 for reckless driving, \$15 of which was remitted by the judge. Williamson drove his car at a reckless speed across the west end of the football field and through a single wire which surrounded the field. Onlookers were endangered by the wire which was trailing behind the car.

### Road Construction Ordered.

The Umatilla County Court has ordered grading and graveling done on roads in the Minnehaha district. A crew of fifteen men with teams and trucks are stationed in Hermiston this week. It has not been determined when the work will be completed.

## "LET'S SELL OREGON TO OURSELVES" CAMPAIGN OPENS

### OREGON PRODUCTS WEEK FEATURED THROUGHOUT STATE.

Effort Being Made to Make People More Oregon Products Conscious.

The products of western factories will go on parade throughout Oregon the week of November 17 to 24. Plans have just been completed by the Oregon Manufacturers association for a statewide campaign to encourage the more extensive use of these goods with the idea of building state payrolls and increased demands for the raw materials of farm, stream, forest and mine.

On page two of this issue the local merchants have tied in with this state-wide campaign by advertising Oregon made products. Banners are being displayed along with Oregon products displays in windows of the local business houses.

The campaign is being headed by former Mayor George L. Baker of Portland, who now is manager of the Oregon Manufacturers association. Through the medium of newspapers, radio, magazines, window displays, mass meetings and special sales, the importance to Oregon of a concentrated support of the products of western factories will be driven home.

The factories are cooperating to the extent of providing the stores with advertising, window displays, and products with which to conduct special sales. It is their purpose to show the people of Oregon that the products of our own western factories are the equivalent of those of other sections and that by discriminating in favor of them, the state is being built up in payrolls, employment, and general prosperity.

"It is not just a week of sales of western products," explains Manager Baker, "but a campaign to show our people the importance of supporting their own factories in preference to those of sections doing us no good. We hope to build up the demand for western products and to make that demand permanent. By so doing, we will increase payrolls and will create a greater field for industry here. This is very essential with completion of the Bonneville power project coming upon us."

## DRUNKEN DRIVING RESULTS IN INJURY OF TWO PERSONS.

Mr. and Mrs. E. Miller of Hood River, were injured seriously Sunday morning on the highway about 25 miles east of The Dalles when the motorcycle on which they were riding was struck by a car approaching from the rear. The driver was later charged with drunken driving. Word was received here Sunday afternoon by Mrs. Miller's parents, Mr. and Mrs. Wm. Davis, who left immediately for The Dalles where the victims received first aid treatment. Examination revealed that Mr. Miller had suffered a fractured thigh and lacerations about the face. Mrs. Miller was badly bruised and suffered from nervous shock.

The Millers were enroute to Hermiston, accompanied by Mr. and Mrs. Carl Harmon, to spend Armistice day with the Davis family and had stopped at a railroad crossing to let a switch engine pass, when the speeding automobile overtook them as a west bound truck pulled across the track. The driver of the truck witnessed the accident, it was reported.

The two machines were badly demolished.

### HANELINES VISIT WILD BIRD HAVEN AT TULELAKE, CALIF.

Motoring to Klamath Falls last Friday, Mr. and Mrs. B. Haneline spent a very enjoyable week end visiting their son and daughter-in-law, Mr. and Mrs. Herbert Haneline. A side trip or two to the south of Klamath Falls revealed many scenic spots of beauty and interest, among the latter being the Tulelake lava caves, which are maintained by the government as a wild bird preserve. Here the wild game birds seek refuge and are to be seen in great flocks, the wild geese at this period greatly outnumbering any other species. The visitors were amazed at the myriads of geese seeking protection, food and rest at this preserve, before continuing their migratory flight.

Approaching the crater, Mr. Shasta loomed a little to the right in the foreground. After reaching this spot, they were afforded a view of a natural bridge formed by the rock having fallen away. Here also is the historic battleground of the Modoc Indian war. In this vicinity is the shortest river in the world, only one-half mile in length, linking Klamath lake with Ewald lake.

During their stay in Klamath county, the weather was fair but on the return trip they drove through snow in the Rogue River national forest. At this point there were many snow markers along the highway, some standing as high as eight feet. A dense fog along the Columbia highway prevented the travelers from reaching Hermiston until late Tuesday evening.

### OREGON HISTORICAL SOCIETY ANNOUNCES ESSAY CONTEST.

The Oregon Historical Society has selected "Marcus Whitman" as the subject for the 1935 C. C. Beekman History Prizes and Medals. The prizes are four in number, first, sixty dollars; second, fifty dollars; third, forty dollars; and fourth, thirty dollars; and will be awarded for the best four original essays on the above named subject written and submitted by girls or boys over fifteen years of age and under eighteen years of age, attending any public or private school, academy, seminary, college, university, or other educational institution within the State of Oregon. Each of the four prize winners will also receive a handsome bronze medal.

The conditions governing the competition are as follows:

(1) The essay submitted in competition must not exceed two thousand words in length.

(2) The essay may be in handwritten or in typewritten form, preferably upon paper of commercial letter size, either ruled or unruled, the several sheets being numbered consecutively and written on one side only, with blank space of about one and one-quarter inches at top and left-hand margin.

(3) The essay shall be accompanied by a separate sheet containing the name and post office address of the writer, the date of his or her birth, and the name of the school attended.

(4) There shall also be delivered with the essay a certificate signed by a teacher or instructor of the educational institution attended, stating that the writer of the essay is a pupil or student attending the same.

(5) In order to be considered in competition the essay must be delivered, by mail or in person, to the Oregon Historical Society, Room C, Public Auditorium, 235 S. W. Market Street, Portland, Oregon, not later than Saturday, March 16, 1935.

(6) All essays submitted in competition will be numbered and submitted, without the names of the writers or other identifying marks, to three judges selected by a committee.

(7) All competitive essays will be judged according to their general merit and excellence; but the judges will also take into consideration, in passing thereon, neatness of manuscript, accurate orthography, correct grammar and composition, and purity and clarity of diction.

## BULLDOGS SCORE 18-0 IN FINAL CONTEST AGAINST HEPPNER 11

### SCORING DONE IN FIRST HALF OVER HARD HITTING IRISH.

Heppner Rallied at Beginning of Second Quarter; Aerial Offense Figured Prominently.

The Bulldogs won a decisive victory over the strong and hard hitting Heppner eleven, in a score of 18-0, on the local field last Friday. Players figuring prominently in the game were Moore, Hensel, Dawson, Cox, Reeves and Whitsett.

The Bulldogs did their scoring in the first half before the Fighting Irish realized what was taking place. Several times the Heppner team made long and sustained drives and on one occasion worked the oval to the five yard line where stubborn Bulldog resistance blasted all hope for a score.

In the first quarter, Heppner passed in midfield, Cox in attempting to intercept, knocked the ball to Reeves, which gave Hermiston the ball on the 40 yard line, where they advanced it to the 22 yard line. From here Moore shot a 20 yard pass to Dawson who ran for a touchdown.

Again when the second touchdown was made, the Irish aerial attack paved the way for the Bulldogs. This time Hensel batted a pass which Dawson caught. Moore then shot a long 35 yard pass to Cox. On the next play Hensel went through the line for a five yard gain, and Moore taking the ball on the 25 yard line ran for a touchdown on an end play.

Touchdown number three came shortly before the half was over. Reeves knocked a Heppner pass in the direction of Cox who caught it scarcely before the side lines knew what was happening and raced 70 yards for the final score.

In the second half Heppner made a desperate effort to score, but this time concentrating on line bucks. The long sustained drives by Heppner climaxed in Hermiston getting the ball and Moore winning back in a few plays the territory that had been lost.
