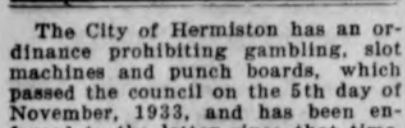

The City of Hermiston has an ordinance prohibiting gambling, slot machines and punch boards, which passed the council on the 5th day of November, 1933, and has been enforced to the letter since that time, in accordance with a corresponding state law. Hermiston is the only town in the county where this law is enforced and in order to preserve the peace, health and safety of the city should be maintained.

team cannot be built in one season. There has been another stir about the construction of a dam on the Columbia river at Umatilla rapids and other dams on the Snake river. Observers point out that only when the government intends to go through with a project is such extensive field work done as is now being carried on by the army engineers on the Columbia and Snake rivers. The engineering corps which has been located at Hermiston for the past two months has recently been re-informed, which is taken to indicate that more intensive concentration is being made to complete the survey by June 1.

The possible expenditure of \$75,000,000 is seen as a result of this work. These periodical breaks into print of possible construction of dams on the upper Columbia and Snake river is evidence that river development on one of the greatest rivers in the United States is being kept constantly before authorities at Washington.

Much Needed Infirmary Granted.

CORVALLIS—Better care for the health of the students of Oregon State college is expected to follow erection of a new \$100,000 infirmary for which PWA funds have just been allotted by the federal government.

The self-supporting health service now at the college is housed partly in a small ancient structure on the campus and partly in an old frame building down town. Of the PWA grant, \$30,000 is to be a gift and the remainder a loan amortized over future years to be retired from income from the regular student building fee. The new building will be located on the north side of the upper campus.
