BOOSTER NIGHT IS PLANNED BY CLUB

AGREE TO SUPPORT ACHIEVEMENT DAY

After an inactive period of almost two months, the Hermiston Commercial club met Tuesday night at the hotel with a record crowd of 22 members. Regular meetings will again be held on the second and fourth Tuesdays of each month. For the next meeting, which will be on November 23, a special booster night will be arranged by a committee composed of W. W. Felthouse, Harold Thompson, Ellis Moyer, John Clarke and Walter Pearson. This committee will endeavor to get every citizen interested in boosting Hermiston to come to this meeting, and will organize a special program to make the booster night a rousing meeting.

The 4-H achievement day banquet has been definitely set for Tuesday, November 30, according to Jay T. Pierson, assistant county agent, who briefly summarized the work of 4-H clubbers in the community. He read a letter from L. J. Allen, assistant state club leader, who took Kenneth Benschel and Eugene Rugg to the National Dairy show at Columbus Ohio. Mr. Allen complimented the boys on the wonderful showing made and stated that Hermiston and Umatilla county had every reason to be proud of the boys.

Mr. Pierson brought out the value of 4-H club work to the community, and stated that the banquet is being given to show appreciation to both clubbers and the community and to help defray expenses. The steer purchased by the Umatilla Project Farm Bureau for this banquet was raised by Chas. Kik and exhibited at the Portland livestock show.

Tickets for the banquet will be sold by clubbers at 75 cents a plate, according to Mr. Pierson. A program has been arranged for the evening on which F. L. Ballard, vice director of extension work at O.S.C., will be one of the speakers. The boys will tell of their trip to Columbus, Ohio, and scholars' tips and pins will be awarded. Two calves, a Holstein, from the Chas. Lynch herd, and a Jersey, from the Happy Thot Jersey Farm operated by H. R. Hartley, will be awarded to the outstanding club girl and boy.

A unanimous vote was taken to close all business houses on each of the three remaining holidays this year, Armistice day, Thanksgiving and Christmas.

E. P. Dodd was delegated to write a letter of appreciation to the Pendleton Chamber of Commerce for their assistance and cooperation during the Umatilla Project fair.

Another committee was appointed to unite with like committees from the cooperative institutions to visit the county court and state highway officers in the interest of better roads and streets. Several heavily traveled country roads nearby, leading into state roads, require oiling as a maintenance project.

The committee will urge construction of the state highway that has been surveyed, with the right of way bought, from Hermiston north to the Wallula cut-off, to connect with the new port at Umatilla. The federal government has set aside \$100,000 for construction of this road and because of grade crossings, the commission will be urged to meet the 35 percent balance needed to build the road.

Several streets in Hermiston, one along the library and school street, and one on First street where the cooperative businesses are located are in bad condition because of heavy use. These and other streets are being considered for oiling in the spring.

O.S.C. POULTRYMAN COMING THURSDAY

Noel L. Bennion, extension poultryman from O.S.C., will be available for a meeting in Hermiston Thursday, November 11, at 8:00 p. m., in the Union church. He will talk on "Factors affecting fall and winter egg production." Mr. Bennion will be in this area this week and will discuss any problems poultrymen may have found in their field.

This meeting will be in the form of a general poultry meeting and anyone interested is welcome to attend. Cards are being sent out by Assistant County Agent Jay T. Pierson to notify all poultrymen.

HERMISTON IS BEATEN 22-0

The Hermiston Bulldogs lost the game 22-0 last Friday to Mac-Hi. They play the final game of the season Thursday with their ancient foe Heppner.

A short account of the Mac-Hi game is given by Cal Anderson in the Union.

"Mac-Hi's Pioneers plunged and swam their way to a 22 to 0 win over the invading Hermiston Bulldogs here Friday afternoon.

"The game was played in a down-pour of rain that turned the field into a duck marsh before play had even started. It was impossible to keep the identity of individuals as each player became completely coated with the soil of Oregon after he had been in the game a few plays.

Mac-Hi dominated the play throughout the contest, constantly knocking at the Hermiston goal on tremendous line smashes by Harold Fox and sparkling reverses that shot elusive runners into the open. Only once were the Bulldogs able to penetrate as far as the Pioneer 45 yard line and there their drive was stopped by the half time gush. The rest of the contest was splashed out in Hermiston territory."

WILLIAM A. HAGGMAN

William A. Haggman was born at Astoria, Or., December 4, 1894. At the age of one he moved to Warren where he resided until 1909, when the family moved to Stanfield, Oregon. When the World War broke out he was among the first to enlist, serving until the Armistice was signed, after which he spent one year in Coblenz, Germany, with the Army of Occupation.

On his return to Stanfield he was employed by the Furnish Ditch company for some time. Later he entered the employ of the Standard Oil company with which he had over 15 years of service. While with this company he was stationed at Stanfield, Hermiston, Pendleton, Milton, Freewater, Walla Walla, Huntington and Cascade Locks.

He died in Portland Emanuel hospital on November 2nd, following a major operation. Services were held in the Presbyterian church at Stanfield, November 5th, and interment in the family plot at the Echo cemetery.

He is survived by his widow, his father Wm. Haggman, Stanfield, two sisters, Mrs. Roy G. Penney of Stanfield, and Mrs. Lloyd J. Russell of Portland.

Pallbearers were Owen Shawgo of Portland, Maurice Schanton of Cascade Locks, Lawrence O'Sullivan of Pendleton, Ralph Richards, George Harkenrider, Grant Walker and Curtis Simons, all of Hermiston.

LIVESTOCK SHIPPERS ASSOCIATION MEETS

Interested members of the Livestock Shippers' association met at the office of Assistant County Agent Jay T. Pierson last week and named Ira Geer as manager to serve until the annual meeting which will be in January.

The association was organized more than a year ago and was patterned after other organizations operating in Walla, Union and Baker counties. The local group has shipped 195,920 pounds of livestock during the past year at a cost of 77 cents per pound to the producer. A total of 129 cattle, 155 sheep and 100 hogs had been trucked to city markets.

For the convenience of livestock producers, cards, and a box, will be placed at the Farm Bureau Cooperative office by which the individual may indicate when he wishes to ship, how many, and what, by merely filling out the card and dropping it into the box. When collected by the manager of the association he will know when to call for the stock and just how to arrange his schedule. The manager will also have a telephone, it was brought out at the meeting.

R. E. A. EASEMENTS, MEMBERSHIPS

Work on the new electrical project is progressing as rapidly as possible. The engineers are in the field staking out the lines and preparing maps for railroad and state highway crossings, making such changes as may be necessary before actual construction begins. The contract with Newport, Kern & Kibbie is in Washington awaiting federal approval. Sixty miles of easements have been secured and new applications for juice are being made daily by farmers. Many have not yet signed membership application for membership in the Umatilla Electric Cooperative association, which is required before service lines are built to their homes.

SOIL CONSERVATION MEET NOVEMBER 19

1938 PROGRAM WILL BE OUTLINED

Umatilla county farmers will elect community committeemen as well as discuss current farm problems and objectives of the 1938 agricultural conservation program at community meetings beginning next week, according to Wm. R. Coppock, chairman of the county agricultural conservation committee.

Community meetings scheduled to date for Umatilla county during the week beginning November 15 are as follows: West Umatilla county, at the Union church in Hermiston, Friday afternoon, November 19th, at 1:30 P. M.

At the same time, these conservation farmers will be given an introduction to the general outlines of the 1938 soil conservation program. Although this program has the same general purposes as those in '36 and '37, it will be much simpler in application to the individual farm, says Jay T. Pierson, assistant county agent.

The first way in which the new conservation program has been simplified is that a single total payment, representing the amount that the farmer can earn, will be calculated at the beginning of the year. Then he will be able to figure out the farming practices he wants to follow through the year.

So that he will have something definite to work toward in carrying out his 1938 operations, two "goals" will be established for each farm. The first of these is a total soil-depleting crop goal, which is simply a measure of those crops which are hard on the soil.

In contrast to the soil-depleting goal is the soil-building goal which will be the mark for the farmer's soil-building practices. These practices will be much the same as those employed in 1937.

If the farmer reaches his soil-building goal and does not exceed his soil-depleting goal, he will receive full payment. On the other hand, if he does not meet them—either by falling short on soil-building practices or going over on soil-depleting crops—his payments will be reduced accordingly.
