SOIL CONSERVATION CAMP PERSONNEL NOW IN FIELD

CC C ENROLLEES AGAIN IN STANFIELD

The assembling of the new soil conservation camp at the CCC barracks at Stanfield is in full force this week and by October 17, 170 boys are expected to arrive.

This company of men and boys have been stationed at Moro, in Sherman county, for the last three years. Much work has been done in erosion and demonstration of crops best suited to the non-irrigated lands of that district. It is expected that they will be here from three to five years as this is considered a very fertile area for soil conservation work, both in the irrigated and wheat and range lands adjoining non-irrigated lands. A definite program has not been set up but will be developed as work progresses and study of conditions is made.

Lieutenant J. T. McKnight will be in charge of the camp, assisted by Lieutenant Spencer, J. R. Chenault is the camp superintendent; E. O. Dyer, soil conservationist and contact man; Therman Powell, engineer; Robert C. Moreland, agronomist; William Mitchell, Roy Tiller, and another man to be named, foremen; Stanley P. Smith, blacksmith; and L. O. Harlan, mechanic.

A number of these men have families and have been busy this week looking for houses. Some have located suitable homes in Stanfield, Hermiston and Echo. Several have children who will enter local schools. Work will begin as soon as the camp is organized, and a more definite statement will be made as to the character of the work to be done. The camp comes here with equipment in which are eight state trucks, three dump trucks, tractors and grading attachments.

TOWNSEND MASS MEETING ATTENDED

The Townsend club mass meeting held Thursday of last week had an attendance of over 300 people during the afternoon and evening. Jim McKenzie, national representative from Montana, was appointed by Gordon Ware, Oregon's representative, to take charge of the meeting, due to illness of Mr. Ware.

Mr. Goddard of La Grande and W. A. Spencer of Wasco were also speakers.

The evening meeting was to have been given over to Rufus Holman, candidate for U. S. Senator, but illness prevented his attendance.

Questions were asked about the bill that will appear on the ballot this fall known as the "Citizens Retirement Annuity Bill," which some think is the Townsend bill. The speaker explained that Dr. Townsend is opposed to establishing recovery plans in the separate states based on a general transaction tax. Any state adopting such a system alone inevitably penalizes its business and investors. He stated, "The Townsend bill must be national and be run by the United States congress or it cannot work."

McKenzie also told members that the Townsend movement had endorsed Walter M. Pierce for congressman and Rufus Holman as senator from the second congressional district in Oregon.

A short program was given for the evening and a Dutch auction sale of a quilt donated by Mrs. Carl Thompson, was held. Mrs. F. R. Moore, was presented with the quilt. A vote of thanks was given C. L. Hodge of the Hermiston Motor Co., for the use of the loud speaker, and also to Mayor F. C. McKenzie for authorizing the raising of the flag on the day of the meeting.

The next meeting will be held Friday, October 14, in the American Legion hall. Everyone is welcome to attend.

C. E. PENLAND DIES OF HEART DISEASE

Claud Edward Penland, 60, prominent Pendleton man and democratic candidate for county commissioner, died of heart disease at Milton Saturday evening.

Mr. Penland was stricken while leading the singing for the Umatilla Baptist association at Milton. Singing was his beloved hobby and he died as he lived—singing all the way.

Mr. Penland was in business in Pendleton 40 years as a member of Penland Bros., but retired in 1937 because of illness.

Besides his widow, Mr. Penland is survived by his mother, Mrs. Mary Virginia Penland, three brothers, Clarence and Will of Pendleton, and Roy of Helix. Two daughters, Mrs. Merle G. Destin of Portland and Mrs. Fred Beaven of Los Angeles, with three grandchildren, survive him.

Funeral services were held at Folsom's Wednesday at 2:30 conducted by Rev. S. E. Anderson, of the Baptist church.—Pendleton East Oregonian.

SOCIAL SECURITY INSURANCE CREDITS

Any worker who wants to know the amount of his 1937 wage credits, on which his old-age insurance will be based, may find out by asking the Social Security board to send him a statement, according to an announcement by the board today.

For the convenience of those who want such a statement, the board has provided, at all of its field offices, postcards with the request for information printed on the card. All the worker needs to do is to write in his name, address, account number, and date of birth for identification purposes, then sign the card. He can mail the card either in a sealed envelope addressed to the Social Security board, Candler Building, Baltimore, Maryland, where the records are kept, or he can put a 1-cent stamp on the card itself and drop it in the mail box.

VOTERS REGISTER BEFORE SATURDAY

Any voter who has changed precincts since last election is required to register. Voters may register with F. C. McKenzie at the Oregon Hardware & Implement Co.

It is stated that at least 25 per cent of the voters in the two Hermiston precincts are not registered, and this percentage is even greater among women voters. The fall election will include state offices of governor, secretary of state, superintendent of public instruction, two supreme judges and labor commissioner. FUMBLES MAIN CAUSE OF DEFEAT IN KENNEWICK GAME

BULLDOGS RETURN DEFEATED, 19 TO 6

The Hermiston Bulldogs were defeated 19 to 6 by the Kennewick Lions Friday afternoon, September 30, at Kennewick. It was a hard fought game, exciting and aggravating in turn by spectacular passes and heartbreaking fumbles.

Kennewick fumbled on the kick off and Hermiston drove down to the seven yard line only to lose the ball on a fumble. The Lions roared on down from their own seven to Hermiston's 32, and again the ball changed hands on a fumble. After an exchange of punts, a pass was intercepted by Kennewick for a touchdown.

The kick off to Hermiston went over the goal and play started then on the 20-yard line. Hermiston made a sustained 77-yard drive to Kennewick's 3-yard line only to lose the ball on downs. The Lions fumbled and the Bulldogs pounced on it as the half ended.

The third quarter was a see-saw affair with no scores. The ball was in Hermiston's own territory most of the time.

In the fourth quarter Kennewick tried pass after pass but they were no good. The ball reverted to the Bulldogs on downs and they staged a combination of passes and running plays which were climaxed when Elbert Moore ran 45 yards for the Bulldog's lone tally.

Hermiston kicked off to Kennewick but the Lions were forced to punt; the safety man couldn't hold on to it and Kennewick recovered on Hermiston's five and went over on one play. The try for point was no good and the score stood 12 to 6 in favor of the Lions.

Hermiston received and after three plays lost the ball on a fumble on their own 11-yard line. Kennewick again scored on the first play. The try for point was good.

Hermiston out-gained Kennewick in many ways but was unable to keep hold of the ball when it became necessary.
