FOREST TREE SEEDLINGS ARE AVAILABLE NOW

Over half a million forest tree seedlings, grown by the State Forestry Department, are now ready for distribution to individuals throughout the state who desire to undertake tree planting, according to State Forester J. W. Ferguson. The trees are produced solely for the purpose of establishing woodlands, shelter belts and windbreaks on farm lands within the state.

Sixteen different species of trees are included in this year's output of the nursery. Careful selection has been made in order to secure stock that will meet all the soil and climatic requirements of both eastern and western Oregon wherever there are farm habitations.

Such tree selection is especially necessary in the eastern part of the state where the summers are dry and the winters characterized by frequent extended periods of cold weather. It includes such conifers as the ponderosa, Scotch and Norway pines, the eastern Oregon variety of Douglas fir and Norway spruce. The hardwoods include the black locust, Chinese elm, Russian olive and caragana. These latter two are very hardy and will survive under the most adverse weather conditions.

For planting in the western part of the state, emphasis is placed upon the native trees such as the Douglas fir and western red cedar. No imported tree has yet been grown that will equal them in general utility or rate of growth. However,

numerous other trees are produced for specific purposes as the maritime pine for sand fixation.

No ornamentals of any kind are produced as it is the policy of the state not to enter into competition with the commercial nurseries. In order to prevent the diversion of stock for such purposes, individuals ordering trees are required to sign an agreement that they will abide by the state regulations in this respect.

All information relative to species available, how to order, the planting and care of the stock can be secured by writing directly to the State Forester at Salem, or by getting in contact with the local county agent.

ANNUAL CLASS PLAY CHOSEN BY SENIORS

BLINSTON PLAYS "THAT GIRL PATSY"

The senior class, after the usual deliberation, chose for their spring production, the three-act comedy "That Girl Patsy," by Sumner Nichol. The date will probably be Friday, March 3. The play was very popular as stock favorite, having played throughout the country for many years, and only recently released for use by amateurs.

The play will be under the direction of Miss Lavina May Lynch, who directed, "New Fires," the junior play last year, and "Growing Pains," the senior class play the previous year.

Members of the cast were chosen by fellow class mates this year. Try-outs were held before all members of the senior class and everyone voted for the persons he thought best suited to the parts.

A synopsis follows: Mrs. Warren a wealthy society woman, has taken into her home, with a view to adoption, an 18 year old girl from the slums, known as Patsy. Patsy is coldly received by Julia, Mrs. Warren's daughter, and her young friends, especially Violet Manners, who sees in this attractive youngster a potential rival for the affection of Bob, Julia's brother. Patsy, however, with her quaint and humorous antics, soon wears down the family reserve and endears herself to everyone—particularly young Mr. Bob. But suddenly a situation arises which threatens seriously to destroy her one chance of happiness.

Patsy discovers that Julia is in the power of Phillip Greer, a black-mailer, who, unless Julia meets his demands for \$5,000, threatens to sell certain letters to the papers. Patsy takes matters into her own hands—meets Greer on his own ground—disarms his suspicions, and convinces him that she is "working the same racket" on Mr. Warren; then after completely winning his confidence, induces him to let her see the letters. Once they are in her hands, she drops her disguise, and hurls the letters into the fireplace. In a rage, Greer threatens her just as Mr. and Mrs. Warren and Bob enter the room. Mr. Warren demands an explanation which, of course, Patsy cannot give without exposing Julia.

Mr. Warren interprets Patsy's silence as an admission of guilt; he denounces her and orders her from the house. Bob declares his faith in Patsy, but she gently declines his assistance. At the last moment, however, Julia's better nature asserts itself and she confesses. Mr. Warren humbly apologizes and from then on the play takes a decidedly romantic turn until the fall of the curtain.
