SUBSCRIPTION DEAL SETUP EXPLAINED BY HENRY J. OTT

About nine years ago the editors of The Hermiston Herald worked out a pool subscription proposal and offered it to the Umatilla Project Farm Bureau and the surrounding Granges that had membership contact with the various farm cooperatives in Hermiston. The offer was so liberal that it was readily accepted and has been in use ever since. It seems advisable to occasionally clarify the pool setup and so perhaps have a better understanding and less confusion.

The pool subscription price per year is fifty cents. This includes one subscription per family member.

There are two sets of farm organizations considered in this arrangement. One consists of the Umatilla Project Farm Bureau and the various Granges. These are known as farm organizations. The other set consists of the business co-ops—such as Farm Bureau Co-op, Creamery Co-op, Laundry and Cannery Co-op, Turkey Growers Co-op, Mercantile Co-op, etc.

One-half of the subscription price or 25c is paid by the farm organization of which the subscriber may be a member and the other 25c is paid by the business co-ops prorated in proportion to their previous year's gross business.

Eligibility requirement consists of membership in some farm organization such as the Umatilla Project Farm Bureau or the Granges with the dues paid up and the subscriber must also be a member in one or more of the various business co-ops. It must be recognized that the economic betterment of agriculture is dependent upon organized farmers' organizations and this pool subscription has for its purpose to build up membership in farm organizations and to increase the circulation of The Herald in such a way, if possible, that every farmer who is a co-op member will be a subscriber.

The Hermiston Herald has set aside the first three columns of its farm page for any use co-op organizations or farm organizations may need to inform its membership relative to the business or any items of interest to members outside of purely advertising. A requisite is that the contributor's name accompany the article.

NEW AAA RULE TO AID MAINTENANCE OF DRYLAND GRASS

A new soil building practice, that of maintaining a vegetative cover such as grass on cropland, is one of the most important recommendations agreed upon at the recent national AAA conference in Washington, D. C., according to Will Steen, state chairman, and N. C. Donaldson, executive officer, who represented Oregon at the meeting.

This new practice is designed to encourage longer rotation in dryland farming and is expected to be particularly valuable to eastern Oregon farmers who have established large acreages of crested wheat grass on former wheat acreage.

Small farmers will also have a better opportunity to participate this next year, if recommendations are adopted as expected, as these call for setting a minimum soil building allowance of \$20 per farm. State and local AAA committees will have more responsibility for the field administration of crop insurance and loans, in line with established AAA policy of decentralizing administration of the program wherever possible.

The national conference was held a month earlier this year than last to give farmers in 1940 a better opportunity than ever to know well in advance of the planting season what the program has to offer them.

Recommendations adopted at the national conference will be used for drafting specific provisions of the 1940 program. In general, it will continue on the same lines as the 1939 program. Changes recommended are those which will simplify administration of the program, or make it more effective from the standpoint of soil conservation, says the Oregon official.

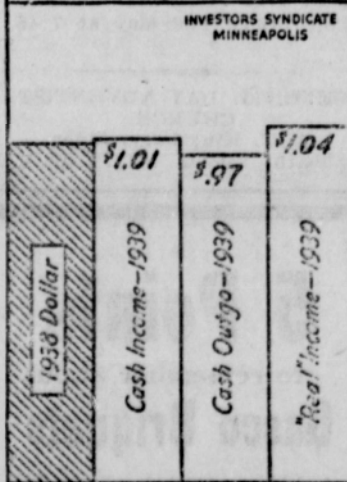
The conservation program provides for establishment of national allotments for soil-depleting crops and a national goal for soil-building crops and practices, which will be broken down to individual farms. The national wheat allotment of 62,000,000 acres for 1940 has already been announced.

American Income Rises 4 Cents; Living Costs Dip Three Cents in Year

PURCHASING POWER JANUARY, 1939, Compared with JANUARY, 1938



THE above chart, showing how the average American fared in national income changes in the last twelve months, is based on the monthly consumers' study of Investors Syndicate, of Minneapolis.

Mr. and Mrs. Public in January had a "real income" of \$1.04, or an increase of 4 cents on the dollar from the same 1938 month. This "real income" is not a subtraction of cash income and expenditures, but an average relative of these figures designed to show how living costs affect adjusted income dollars. Cash income of Mr. and Mrs. Public in January was \$1.01 for every \$1 a year earlier. This gain of one cent on the dollar resulted from the following changes per dollar: wages up seventeen cents and salaries three cents; investment income was down 34 cents and other income was down two cents on the dollar.

Rents were off two cents in January as compared with the same 1938 month. Food was down three cents on the dollar; clothing was off five cents; and miscellaneous items were down four cents.
