POWER RATES ARE COMPARED

By H. J. OTT One serious question confronting all users of electricity in Western Umatilla county is how much we are interested in the acquisition and use of Bonneville power. Below is a quotation from the Bonneville Administration, followed by those rates at Forest Grove and what our rates are at Hermiston at the Farm Bureau Co-op. as of July 31.

the major part of their requirements of power from Bonneville adopt the retail rate schedules now in effect at Forest Grove and Canby, Oregon, where Bonneville power is used exclusively by the municipally owned electric systems."
