**WEED CONTROL  
METHODS STUDIED**

The belief that weed control is a serious problem right now and not one that might become serious ten years from now was expressed by Lawrence Jenkins, weed specialist from Oregon State college, before a large group of farmers in the Stanfield Grange hall Tuesday night. Mr. Jenkins had spent the day surveying weed areas in the west end of the county and expressed alarm at the growth in size of some areas since his last visit. This district may soon find itself in the position of certain areas in other states where large acreages have been abandoned and taken off the tax rolls because of noxious weed infestations, Jenkins said.

Control measures which have already been undertaken were outlined by Assistant County Agent M. E. Knickerbocker, who explained that Umatilla county has had a tractor outfit clean-cultivating noxious weed patches in the Butter Creek area for a year, now, and that it was planned to expand this cultivation practice to weeds in the Umatilla Meadows and Stanfield districts this year. Wm. Meiners, county commissioner, assured the cooperation of the County Court in controlling weed patches on rights of way and other county-owned lands. County Agent Walter A. Holt discussed weed control districts, of which there is one in this county, and outlined that it might be necessary soon to invoke the provisions of this law in order to stop the spread of noxious weeds.

James Gannon, aged 76, passed away at the Hermiston General hospital Thursday morning. Mr. Gannon was born in Baltimore, Maryland, and for many years was a track rider in the Wallula gap district.
