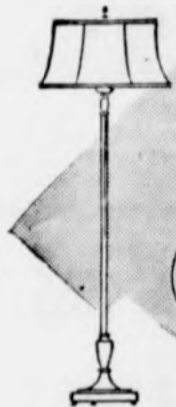
## NOTICE OF HEARING UPON FINAL REPORT
