### Hermiston and Stanfield fire crews extinguish small blaze on Hermiston Butte

#### No structures threatened, no injuries reported

No structures were damaged during a small fire on the Hermiston Butte just after midnight.

Hermiston Fire & Emergency Services Lt. Dennis McClure said the agency was dispatched at 12:12 a.m. to a report of visible flames by the swimming pool on the northwest side of the butte.

He said three Hermiston units and two from Stanfield responded and worked to quickly extinguish the blaze.

"The fire was in steep terrain on the butte in the area behind the swimming pool," he said. "It was controlled at 12:38. That's when the fire was out, and they started to mop up. At 12:55, all the hot spots were put out, and they cleared the scene."

Although he was not at the fire, McClure said the report indicates approximately one acre of grass was burned, but no structures were threatened. He said the cause of the fire is undetermined, but with no signs of arson reported, further investigation is unlikely.

"Typically, for small grass fires like this, we won't go in any farther," he said. "Sometimes, (we are) really just unable to find (the source)."

A controlled burn planned at the butte at 5 p.m. June 25 will probably still occur if the weather conditions are appropriate, McClure said, because only a small portion of the butte was burned in the unplanned fire. The controlled burn was planned to reduce the risk of fire during the July 4 fireworks show.

McClure said people should be mindful of the dry conditions this time of year.

"Conditions are really dry all over the county," he said. "People should be careful of where they burn and what they do. They should just be careful and cautious of their activities in dry areas."

# False report of shooting locks down hospital

# Boardman man arrested in hoax

A reported shooting that turned out to be a hoax briefly locked down Good Shepherd Medical Center on Thursday.

Jose Guadalupe Rizo, 24, of Boardman, was lodged at the Umatilla County Jail on charges of first-degree disorderly conduct, making a false report and misuse of 9-1-1 following the incident.

Officers from Hermiston Police Department, Oregon State Police and Umatilla County Sheriff's Office were dispatched to Good Shepherd shortly before noon after Rizo called 9-1-1 and claimed he had shot someone at the hospital. When officers arrived, they determined that no one had been shot, located Rizo and took him into custody without incident. Hermiston Police Chief

Jason Edmiston said it appeared "alcohol and/or other potential mental issues were at play."

The incident may have caused some public inconvenience and alarm, but it did provide an opportunity to put emergency procedures at the hospital into practice. "In the past, we have participated in tabletop discussions with members of the hospital so it is nice to see a relatively seamless flow between the police response and the hospital policy and procedures," Edmiston said.

Good Shepherd spokesman Kelly Sanders said Rizo also appeared to have pulled a fire alarm before being taken into custody. He said the medical center was grateful for the quick response by police, even if it turned out no one was injured.

"There was nothing really to it, except it was good practice for a situation like that," he said.
