Wyden to hold town halls in Boardman, Arlington

U.S. Sen. Ron Wyden, D-Oregon, will visit Boardman and Arlington on Sunday as part of his promise to hold annual town hall meetings in each of Oregon's 36 counties.

Wyden will stop first at Boardman City Hall at 1:30 p.m., before moving on to Arlington City Hall at 4 p.m. The senator has held 745 town halls since being elected to the Senate in 1996.

"Throwing open the doors of government is how we do things in Oregon and the best way I know to follow the Founding Fathers' intent that elected officials hear directly from their constituents," Wyden said. The meetings are free

and open to the public.


