Ballot Title: FIVE-YEAR LOCAL OPTION LEVY FOR MOSQUITO CONTROL OPERATIONS

Question: Shall the District impose \$.05 per \$1,000 of assessed value for operating purposes for 5 years beginning 2017-2022? This measure may cause property taxes to increase more than three percent.

Summary: The West Umatilla Mosquito Control District will use the tax revenue from this measure to provide improvements to general operations, including the following:
• Maintain the response to West Nile Virus or other mosquito-borne disease.
• Continued utilization of aircraft for mosquito control operations.
• Continued outreach programs and public education efforts.
• Maintain and upgrade vehicle and equipment.
• Increased surveillance for emerging diseases including Zika virus.

The proposed levy will raise approximately \$133,000 in 2017-18, \$135,660 in 2018-19, \$138,373 in 2019-2020, \$141,140 in 2020-2021, \$143,963 in 2021-2022. This estimate tax cost for this measure is an **ESTIMATE ONLY** based on the best information available from the County Assessor at the time of estimate and may reflect the impact of early payment discounts, compression and the collection rate. The levy would cost the owner of a home with an assessed value of \$100,000, \$5.00 per year.
