7-Eleven robbed Sunday night

The Hermiston 7-Eleven was robbed Sunday night.

Police received a call-out at 9:17 p.m. about the robbery at the convenience store at 775 Highway 395, Hermiston.

"Our officers were on scene within seconds of the incident, said Hermiston Police Chief Jason Edmiston. He said two officer

were nearby in the Hermiston Community Center parking lot when the call came in.

"The subject got away with less than \$400," Edmiston said, and the investigation is ongoing.

The suspect is described as a man in his 20s-30s who entered the store and demanded money from the

register but did not display any weapons. The initial call reported the man was black or Hispanic and he left south on Highway 395 in a dark colored Cadillac SUV.

Edmiston also said he cannot release more information at this time and police plan to scour surveillance footage to learn more.
