## HERMISTON — Hermiston driver faces a felony after police claimed he crashed into a bicyclist and left the injured rider at

Hermiston Police Capt. Travis Eynon in a written statement reported officers at about 5:58 p.m. responded to Northeast Fourth Street and East Gladys Avenue for a vehicle versus bicycle collision.

The bicyclist, Jason M. Simpkins, 29, of 638 N.E. Dakota Court, Hermiston, was riding southbound on Northeast Fourth when a north-going Chevrolet Impala turned left onto East Gladys Avenue, according to Eynon, and into Simpkins' path. Simpkins and his bicycle hit the right rear quarter panel of the Impala, which did not stop.

Eynon stated a witness to the crash followed the Impala a short distance and provided officers with a license plate and a description of the driver.

Simpkins suffered minor

injuries and received medical treatment at the scene.

Officer's went to 915 N.W. Stockton St., Hermiston, where they found the Impala, which had extensive damage to the right rear quarter panel. They also found Federico Ricardo DeJesus, 44, who lives at the address, and arrested him on the felony of failure to perform the duties of a driver to injured persons. Police also arrested DeJesus for driving while suspended/revoked, a misdemeanor. Officers processed DeJesus at the police department, then booked him into the Umatilla County Jail, Pendleton.
