and he attended Irrigon schools until he graduated in 1954. Dan learned to Creamer

run tug boats while still in school and worked on several ferryboats. He worked on the Paterson Ferry, Richland Ferry, Maryhill Ferry and Vernita

Ferry. During his senior year, Dan was working on the Paterson Ferry and dating his future wife of 62 years, Rita Jean Reeves. In 1958, he joined the Navy and went through "Boot Camp" and was the Honor Man of his unit. His Navy experience was short lived with honorable discharge an due to osteoarthritis in his knees. He returned home to run ferries and line boats for Tidewater and Inland Navigation. During this time, he and Rita Jean started raising their three children.

For a short while he worked for the Union Pacific Railroad, but again returned to the tug boats and was eventually sent to Stockton, Calif., on a huge sand bar project to rebuild a portion of Interstate Highway I-5. Dan was also employed at the Army Depot on the train. In 1974 he was injured in a train/truck accident. The injury received kept him from his normal type of employment, and then he began a different type of life.

He was on the Morrow County Planning Commission, Morrow County Budget Committee, he was a Port of Morrow commissioner (1989-2005)


