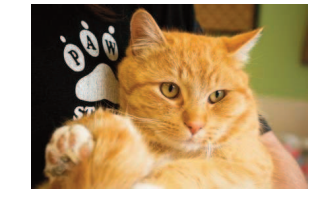

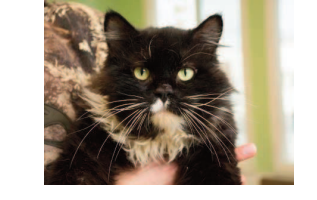

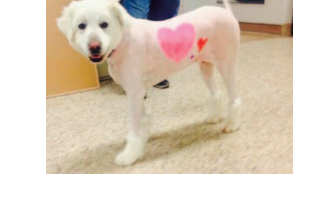

The purpose of the hearing is to consider the creation and application of a Neighborhood Commercial Overlay Zone. The proposed location for the application of the Neighborhood Commercial Overlay Zone is as follows:
