He especially enjoyed the beauty of Salt Lake City during the next 16 years, where he pursued his love of gardening with a showman-like vard of wonderful fruit trees, beautiful flowers and shrubs, as well as a raisedbed rose garden with 12 to 15 lovely tea roses.

He retired from the federal government in 1993, and he and Jonene enjoyed several years of traveling as they visited national parks throughout the country, visiting 48 states, Mexico and Canada.
