Martha Elizabeth Ruebush Lanham, the daughter of George Yates Ruebush and Halley Whaley Ruebush, was born Oc-

tober 8, 1920, in Macomb, Illinois. She was raised on a farm north of Good Hope, Illinois, and graduated from Good Hope High School in 1938. In 1942, she graduated Lanham

from what is now Western Illinois University in Macomb, Illinois, with a bachelor's degree in business education. She taught in high schools in Augusta, Illinois; Walsenburg, Colorado; Hermiston, Oregon; and Barre, Vermont.

When teaching in Hermiston, she met her Wilfuture husband, liam "Bill" Lanham, who owned the local Western Auto store. They were married on September 4, 1948, in Macomb, Illinois. She did bookkeeping for their business while raising a family and later owned a gift shop, "Martha's Door."

Martha was an active community member and volunteered for numerous organizations over the years. She was a member of PEO for over 50 years. She was a founding and active member of Faith Presbyterian Church. She expressed her artistic nature in numerous ways, including painting, spinning and dyeing, felt making, quilting, and interior decorating. She faithfully arranged the church flowers. She was an active person over the years and appreciated nature, whether hiking, rafting, or sitting in her garden watching the birds. She looked forward to yoga classes through Blue Mountain Community College. Always curious and independent, she enjoyed traveling both nationally and internationally.

After Bill died in 1993, Martha lived alone and proudly maintained her home and yard until moving to Wheatland Village in Walla Walla, Wash., in April 2015. She lived in her own

apartment until her death on October 30, 2017, following a massive stroke.

She is survived by daughter, Rebecca Hendricks (Scott) of Milton-Freewater, Ore.; son Ray Lanham (Lynn) of Salem, Ore., and daughter Sara Lanham of Piedmont, Calif. Crews respond to multiple fires

The Umatilla County Fire District responded to two chicken-related fires last Wednesday.

In the first, at Townhouse Villa Apartments, no one was injured and the damage to the unit was fairly minor. Around 2:30 p.m., residents of the apartments at 1100 S. Hwy. 395, smelled smoke coming from one of the apartments, and knocked on the door to see if anyone was there. They called the fire department, who responded and busted the door open. Smoke poured out of the door and out of the upstairs window. No one was in the apartment, but the cause of the fire was a whole chicken that had been left in a pot on the stove and was smoldering.

Apartment owner Mike Jewett said four people live in the two-story unit, and they were notified of the fire shortly after it happened.

"The damage was minimal," he said. "It was mostly from where the firemen broke down the door."

Rachel Strickland, who lives next door to the unit that was smoking, said several of the neighbors smelled smoke and heard the fire alarm going off. Getting concerned when no one answered, Strickland

said she called the fire de- Fire District crews put it partment.

"I panicked," she said. About an hour earlier, a chicken coop on East Punkin Center Road caught fire, and was fully engulfed before Umatilla County

out. The fire was close to the house on the same property, but did not affect the home. Fire Marshal Tom Bohm said the fire was caused by a heat lamp, and that five Guinea hens died.

Suspected car prowler arrested

Hermiston Police arrested a suspected car prowler on Tuesday. Frank Walker, a Umatilla resident, was arrested around 2:30 a.m., for allegedly stealing purses out of several vehicles.

While night shift officers were patrolling a neighborhood near Southwest 17th Street and Southwest Riverhill Drive, they noticed a suspicious vehicle leaving the area. While catching up to the car, an officer saw a purse in the street, which they thought was tossed from the suspicious vehicle. The officer stopped to collect the purse, and another officer stopped the car. The investigation led to the arrest of one of the vehicle's occupants, Walker. Officers said Walker had allegedly stolen the purse from another vehicle before being spotted by the officer.

Walker was lodged at the Umatilla County Jail on charges of unauthorized entry to a motor vehicle, first degree theft, unlawful possession of methamphetamine, and offensive littering, "because even if the purse is stolen, you can't just throw it in the street."

"The officer's report did not specify if the purse matched Walker's shoes," the department wrote on

Facebook.

Walker has been arrested 15 times and has been issued 27 citations.

Hermiston Police said the case is an example of the uptick in thefts from vehicles they've seen lately. They said many of the thefts could be prevented by people locking their cars, taking their keys and removing valuables from the vehicle.
