Police Department's Facebook page, at about 4:40 p.m. on Friday two men, ages 26 and 27, reported that they had been together on the Oxbow Trail when they came across Young sitting along the trail with his dog consuming alcohol. Neither of them reported knowing him previously.

pulled out a folding knife and held it to the throat of one of the men while saying he intended to kill someone.

"As the victim male pushed the knife away from his own throat, he received a very minor cut to one of his fingers that did not require medical attention. The men were eventually able to get

away from Young when he was distracted by a jogger in the area," Lt. Randy Studebaker wrote.

Officers responded and were not able to locate Young, but later took him into custody at his residence for menacing and an unrelated warrant for his arrest out of Jackson County. Police said it appeared to be an isolated incident, and that more charges were possible as the investigation continued.

Woman faces charges 15 counts of theft from former employer

second-degree theft for stealing at least \$100. The indictment alleges Heyne committed the thefts from June 2016 through May 2017.

Heyne pleaded not guilty to all counts at her arraign-March ment according to court records.

Zeller said the business discovered the crimes last June, right as they were

hustling to keep up with rising temperatures. Making a go as a small business is tough enough, he said, and this situation "kind of took the wind out of our sails.'

Heyne signed an agreement to follow certain restrictions to avoid jail, including not having contact with Eclipse Heating and Cooling. The court found she was not eligible for a public defender. The next hearing in the case is the afternoon of March 26 in the Hermiston courtroom of Circuit Court Judge Dan Hill.
