


#### Mary Laura VanKirk Kennewick, Washington December 3, 2019

# **Energy Facility Siting Council to meet**

SALEM — Oregon's Energy Facility Siting Council will meet on Dec. 19-20 in Pendleton. The public meeting begins at 5 p.m. Dec. 19 and will reconvene Dec. 20 at 8 a.m. at the Red Lion Inn. 304 S.E. Nye Ave.

The main item on the council's agenda is the Boardman to Hemingway Transmission Line. The council will receive a presentation Dec. 19 from Oregon Department of Energy staff, reviewing the B2H Draft Proposed Order, comments received on the DPO and responses from the project's applicant, Idaho Power, to those comments. The agenda item continues Dec. 20 and the council may provide staff comments they would like to see reflected in the proposed order.

The proposed 500-kilovolt transmission line would span about 280 miles in Oregon and five counties, including Umatilla, Union and Baker counties. The next council meeting is tentatively set for Jan. 24 in Hood River.

# Rowan to head state sheriff's association

UMATILLA COUNTY Umatilla County Sheriff Terry Rowan has been chosen as the new president of the Oregon State Sheriff's Association. Rowan previously

served as vice president

of the organization, which provides training, lobbying and other services for the sheriff's departments in all 36 counties. He will continue representing the viewpoint of Eastern Oregon sheriffs in his new role.

Rowan is in his second term as Umatilla County sheriff. He was first elected in 2012, after previously serving as undersheriff for about seven years.
