# **April brings new** grant opportunities for businesses affected by pandemic

State and federal COVID-19 relief legislation will present more grant opportunities to businesses in April.

are open on Nov. 20, 2020.

The Restaurant Revitalization Fund is a \$28.6 billion grant fund created by the American Rescue Plan, the latest federal stimulus package. The Small Business Administration has not named a specific date yet for applications to begin, but has said it expects to open the application period sometime in April.

According to the SBA, the fund will provide taxfree federal grants to restaurants, bars, food trucks and other eateries to cover their losses caused by COVID-19 and related restrictions since February 2020. The list of eligible items for the grant money to be spent on includes payroll, rent or mortgage, utilities, food and beverages, cleaning supplies, paid sick leave and expenses related to creating outdoor dining areas. Publicly traded companies or those with more than 20 restaurants are not eligible.

The U.S. Chamber of Commerce is urging restaurant owners to prepare now, before the grant period opens, by registering with the federal System of Award Management and preparing documentation of gross revenues for 2019 compared to 2020. On April 8, the Small Administration Business

also expects to open applications for the Shuttered Venue Operators grant, for venues affected by COVID-19.

Qualifying include event venue operators, theatrical producers, live performing arts organizations, movie theaters, museums and more. For organizations in operation before January 2019, grant awards will be for 45% of gross revenues from 2019 or \$10 million, whatever is less. Business Oregon just closed its first round of applications for the Commercial Rent Relief Grant, but expects to open up another application period in mid-April. The grant is available to help commercial landlords and small business owners by providing rent money for tenants with fewer than 100 employees that have fallen behind on their rent payments because of the pandemic.

## **Deadly virus found in** Oregon, Idaho rabbits

Oregon wildlife and agriculture officials have confirmed the presence of a deadly virus in feral domestic rabbits in a Portland suburb, sparking concerns the disease could spread to wild rabbits in Oregon.

On March 14, the Oregon Department of Fish and Wildlife received a report that eight domestic or feral rabbits were found dead in Milwaukie.

Ryan Scholz, state veterinarian for the Oregon Department of Agriculture, was notified and had one of the rabbit carcasses delivered to Oregon State University for testing. Results came back positive for Rabbit Hemorrhagic Disease Virus 2 on March 24.

The disease does not pose a risk to humans, but is highly contagious among rabbits and can spread through contact with other infected animals or contaminated food and water, causing acute illness or sudden death.

"At this point, we are confident that all eight of the rabbits died from RHDV2, and the virus has taken hold in the feral rabbit population," Scholz said.

### **HELP PREVENT SPREAD**

The Oregon Department of Agriculture recommends several steps to prevent the spread of Rabbit Hemorrhagic

Disease: · Wash and disinfect hands, clothing, gloves, footwear, cages and equipment between handling rabbits from

- different sources. Quarantine new rabbits away from existing ones
- for 30 days. • Keep pet rabbits inside to avoid exposure.
- · Immediately contact ODA if you suspect RHD or have sick or freshly dead rabbits.
- If you have animals not freshly dead, double plastic bag them and dispose of in a landfill.

Rabbit Hemorrhagic Disease was also recently discovered in two wild jackrabbits in Ada County, Idaho, southwest of the Boise Airport.

There is no treatment, cure or vaccine for the disease. Symptoms in rabbits may include fever, lethargy, lack of appetite, lack coordination, excitement or nervousness, difficulty breathing, congested membranes around the eyes or bloody, frothy nasal discharge at death.
