The United States Department of Agriculture Natural Resources Conservation Service (USDA-NRCS) in Oregon, with assistance from Farmers Conservation Alliance and in cooperation with the Hermiston Irrigation District as the project sponsor, is considering improvements to aging irrigation infrastructure in Hermiston Irrigation District. Improvements under consideration may be partially funded through the Watershed Protection and Flood Prevention Act of 1954 (PL83-566) and will address water conservation, enhancement of wildlife and aquatic species habitat, and reduction of public safety risks while supporting existing agricultural land use.

The proposed project is located in Umatilla County, within Hermiston, OR. The National Environmental Policy Act (NEPA) and the Council on Environmental Quality's regulations at 40 CFR Parts 1500-1508 require an evaluation of potential environmental impacts associated with federal projects and actions with input from the public.
