
The cause of the lights going out so many times during the entertainment in the Artisan hall Tuesday evening was not the fault of the Electric Company nor through any fault of the

> County Treasurer to be tax collector instead of Sheriff.

> County Commissioners to be added to Board of Equalization.

> Appeal against assessment to be made directly to Circuit Court instead of under present injuction and review proceedings.

> Methods of assessment to be same as now, except as to public service corporations.

Such corporations to be assessed by a state tax commission on capitalized net earnings.

The commission to have advisory and supervisory power over County Assessors.

Washington system of collecting delinquent taxes and issuing tax deeds to be adopted.

State school lands, sold, but not deeded by state, to be assessed.

County Assessors to certify under oath that they have assessed at ful
