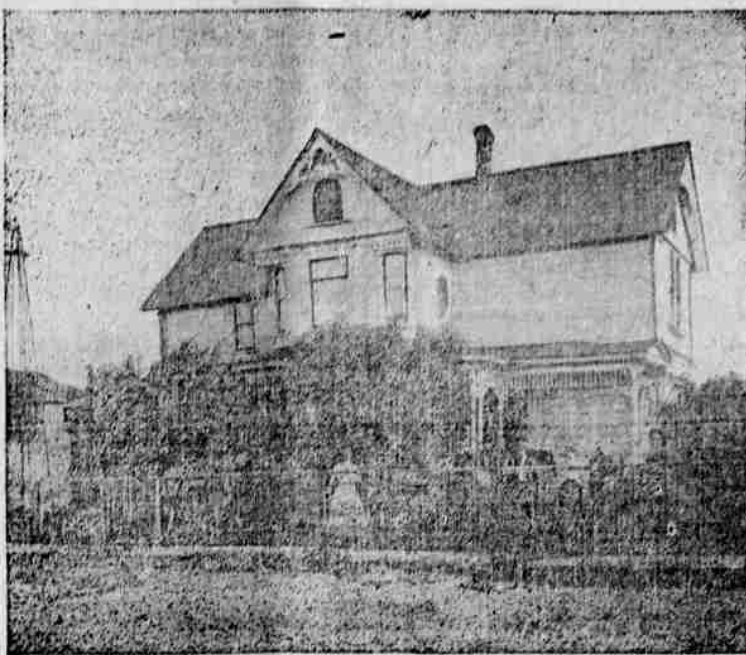
Mr. and Mrs. Lawrence Palmer came in from the mountains Tuesday. They were accompanied by Miss Grace Palmer, who is improving very much in health.
