SHOULD INTEREST VOTERS

EDITOR BULLETIN:

There was surprise expressed by nearly every one who attended the meeting in Stroup's Hall, last Saturday evening, at the lack of interest as manifested by the very small attendance at the meeting in what is certainly one of the most vital subjects to be passed upon by the voters of this State on the 5th day of November next—that of Single Tax.

Mr. Shields is certainly well posted on the subject and those who failed to attend the meeting missed an opportunity to get posted on the subject that they may not again enjoy before they will be called on to cast their vote on the measure.

There are other subjects on which the voters should post themselves, as shown by the pamphlets sent them by the Secretary of State, and I observe that attention is called to the matter by a notice posted on the bulletin board calling a meeting this week at the Baptist Church for the purpose of organizing to study these different measures, so that we may vote intelligently at the polls in November.

Under the laws of this state every voter is equally, with every other voter, a law-maker, and is thus under obligation to himself and the people of the state at large to as thoroughly as possible post himself on every issue that will be presented at the election, and by the people in general turning out to these meetings and taking part in the discussion of the various subjects, we will each be better qualified to cast at least a more intelligent vote.

Let us all get together and meet as often as practicable between now and the date of election and study all these questions, some of which are no doubt of vital importance to each of us, perhaps much more so than who is to be the next President.

PARAGRAPHS FROM IMMANUEL CHURCH

In his sermon last Sunday on "Getting ready to vote," speaking on the general relation of the church to society as a whole, Mr. Hargreaves said in part: If the world is to be saved thru the centralizing of thought on the individual, a method largely in vogue at present, the process will be hopelessly long.

Sins are social as well as personal. Some of our most abominable conditions will be radically changed as social conditions change. Individuals may be saved from the grave of the sensualist by the centralized effort upon a given person, but multitudes may be saved by the modification of economic conditions and the breaking up of certain dens of vice thru the joint effort of properly organized well-meaning people.

The individual church should forget the idea of "building up" itself, and become abandoned to the service of society as a whole. Jesus paid little attention to an organization and in His circle there was a spontaneous co-operation most pronounced and marvelous.

The business of the Church is with the affairs of today. Its services of worship should be incidental and subservient to the great ideal—the expressing of practical interest in the everyday needs of people. He shows the most worshipful attitude to God who entertains and practically expresses deep regard of and concern for God's creation. In estimating a man's Christian life, his ideas of citizenship are a better guide than his ideas of Jesus. A correct impression of Jesus is a thing felt. The expressions of real faith in Jesus

will not be uniform as to theories, but they will be uniform in life activities.

On the specific question of "Getting ready to vote," he said: Important as is the study of the Bible, an even more important object of our immediate exertions would be a careful and honest study of the ballot to be voted on at the November elections. It is irreligious and non-Christian to vote unintelligently.

Under our system of the Initiative and Referendum, the man who will not study the ballot has no moral right to vote. The vesting of power in the whole people may be ideal and desirable, but it has its dangers. Not every man is equal to the duties of a legislator, at least not without training. Intuition will not guarantee intelligent voting in Oregon's 1912 election.

God's Kingdom is as wide as the interests of mankind. His affairs are carried out in state executive buildings as well as in the dedicated church buildings. Just as great care should be exercised in choosing government officials as in selecting gospel ministers.

CHRISTIAN CHURCH ENDORSES GOV. WEST'S WIFE CRUSADE

On account of the active and noisy enmity of certain classes who have been interfered with by Gov. West's campaign against lawlessness, it has been deemed both right and expedient that the friends of order and decency should give expression to their sentiments in regard to his work; and in response to an effort now being made to secure such an expression, the following resolution was unanimously adopted by the congregation of the Christian Church of Mosier in open meeting, on Sept. 15, 1912:

Oswald West is making an earnest and vigorous effort to do this for the State of Oregon, be it
