### FARMERS AID CITY IN GRADING ROAD

Accepting a proposition from the city council whereby the city agreed to furnish the gravel tailings to be placed on the road leading up the hill past the school house, provided the farmers along the road furnish the teams to do the hauling, work was commenced Monday morning. Those who have placed teams on the work are C. A. Morden, H. H. Neilson, V. C. Young, Kenneth L. Cooper, J. E. Procter, E. Jacobson, Geo. Young, and F. S. Senn. The tailings are being hauled from the pit at the crusher. Work is being done on the half mile stretch of road within the city limits. Drainage troughs are also being put in.

This road has been in bad condition especially during the winter months. To properly repair this road the city council deemed that the funds were not available, so the plan of co-operation with the farmers to place it in as good condition as possible, is meeting with approval.

### 58,589 Books in University Library

Fifty eight thousand five hundred and eighty nine volumes are now contained in the State University library at Eugene. During 1915 there were added by purchase, or by binding of periodicals, 3842, and by contribution, 3230.

Citizens of the state outside of Eugene are beginning to use the library more freely under the parcel post plan, says a dispatch from Eugene. Six hundred and twenty four packages of lent books were mailed during 1915.

A special collection of books on Oregon and of books by Oregon authors is being made.

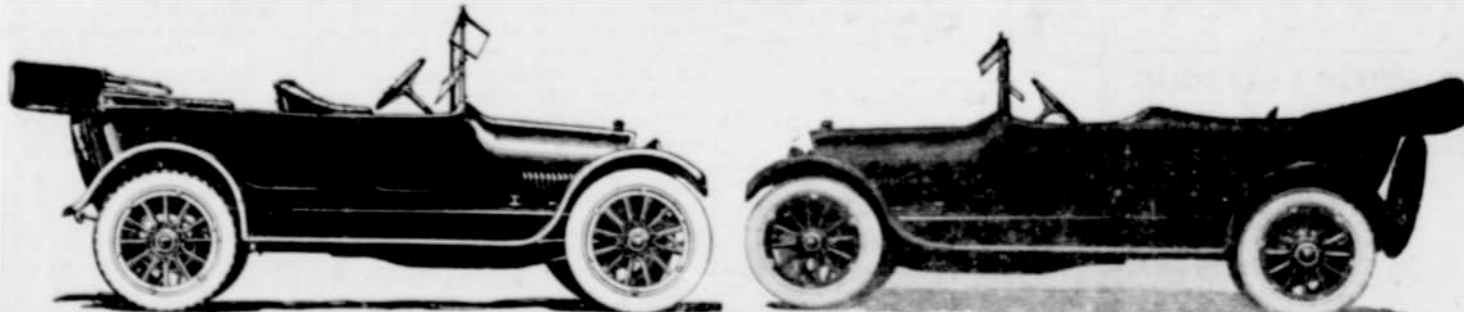
