A. J. EVANS SHOT THROUGH THE HEAD

Alfred J. Evans was found dead Sunday near The Dalles after a bullet from a U. S. Springfield rifle had gone through his head.

The first knowledge of his death reached here Monday when a news item from The Dalles appeared in the Portland Journal. Mrs. V. C. Young, aunt of Mr. Evans, went to The Dalles to investigate and learned that a man hunting for his sheep had come upon the body and had phoned to the sheriff and coroner who soon arrived. The body, it was stated, was so badly decomposed that it was necessary to bury it at once.

A check from J. R. Wilcox, a hunting license aided in identifying the young man, although the coroner did not get citizens knowledge regarding the matter Sunday night and the first knowledge was gained the next morning from the newspaper account.

Considerable feeling was aroused, and when Mrs. Young returned Monday she was met by a large crowd of the body, local citizens refused Tuesday morning to proceed with the funeral when the coffin box, hermetically sealed, arrived. They stated that the body should be identified by someone. Accordingly, Coroner Burget was asked to come down from The Dalles and arrived on the afternoon local. He opened up the box, and although badly decomposed, was able to identify the body by his clothing and hands that the body was that of Alfred J. Evans, and burial took place at once in the I. O. O. F. cemetery.

Some are inclined to believe it a case of suicide, but the relatives believe that it must have been an accident as the young man, who was 25 years old, had no worries or trouble of anyone's knowledge. He was a man of his word and highly respected and had lived here the greater part of his life. Quiet in his manner and preferring to keep to himself mostly, he was well liked by all. Mr. Evans was secretary-treasurer of the Mosier Rifle Club and had always taken an active interest in the organization.

Alfred J. Evans left Mosier last Wednesday night, with his gun and was last seen on the road towards The Dalles. He stated that he was going on a long hunt and might not return. His friends, however, thought nothing of the remark and were deeply concerned when the news of his death reached here.

Paul Evans, a brother, is expected this week from Sheldon, Iowa, to take charge of his affairs.

Cooperation of the right kind was shown a week or two ago in Hood River valley. Whether the apple crop was ready to harvest there was not sufficient help to gather the fruit and serious loss was threatened. The public schools were dismissed and the business men of Hood River closed their stores and all went into the orchards and gathered apples until the last Spitzenburg and Newtown was in the box. It was a display of mighty fine community spirit.—The Packier.

LOOP TRIP IN CASCADES APPEALING

Like the setting of some grand nature stage in this charming scene through "The Divide" of the Cascade range, as viewed from White Salmon's macadamized "Hood View Road." On the edge of the forest in the foreground is the Evrie resort; the high peak at the extreme left is Mount Defiance, on the west line of the Hood River valley; Oregon on the 1 ft and Washington on the right; the Columbia river highway skirts the Oregon shore, and the State highway from Vancouver to White Salmon, the Washington shore, the Oregon-Washington Railway and Navigation on the Oregon side of the river, with the North Bank line on the Washington side.

This loop trip, Portland to Hood River, auto ferry, White Salmon to Vancouver and Columbia river interstate bridge to Portland, when completed, a comfortable one-day run of some 150 miles, will rival any scenic stretch of length in the west.
