## \$90,000 IS PAID FOR FRUIT LAND

Syndicate of Kentucky, Ohio and In-  
diana People Purchase 620-Acres  
Tract Near Eagle Point and Will  
Plant It All in Orchards—Land  
Lies Along Pacific & Eastern  
Railroad.

A syndicate of Kentucky, Ohio  
and Indiana parties, represented by  
J. E. Thompson of Brown County,  
Ohio, and J. W. Hogsett of Rushville,  
Ind., Saturday closed a deal where-  
by they became owners of 620 acres  
two miles northeast of Eagle Point,  
paying \$90,000 for the property. The  
purchasers will incorporate and  
plant 300 acres this winter to  
fruit, and the balance the following  
year.  
The property purchased lies along  
the line of the Pacific & Eastern  
railroad, which will construct a sid-  
ing for the orchard. It consists of  
140 acres owned by Frank Brown,  
160 acres owned by J. F. Nichols,  
160 acres owned by J. E. Hart and  
160 acres owned by Arthur Nichols  
and Wilbur Jacks.  
There are three orchards on the  
property now, 30 acres of 7-year-  
old apples and pears, 20 acres of  
one-year-old apples and 10 acres of  
eight-year-old apples and pears.  
The sale was made by Benj. C.  
Sheldon, who is interested with the  
purchasers.

## WATTERSON SHOOTS MAN

Demented Son of Famous Editor  
Tries to Kill Hotel Proprietor and  
Is in Prison Awaiting Examina-  
tion for Sanity.

SAUGERTIES, N. Y., July 2.—  
Ewing Watterson, son of Henry Wat-  
terson, the famous editor of Louis-  
ville, Ky., was arrested today and  
placed in jail on a charge of insanity  
following an attack yesterday on  
Michael Martin, who was probably  
fatally wounded.  
Watterson, it is declared, has been  
on the verge of mental collapse for  
years. Yesterday, it is alleged, he  
was seized with a sudden mania and  
threatened to kill a bartender in a  
hotel of which Martin is the prop-  
rietor. It is alleged that Martin  
interfered and Watterson fired at  
him, wounding him three times. Wat-  
terson ran down the street, followed  
by a crowd. He fired several shots  
at his pursuers. He will be held  
pending the outcome of Martin's  
wounds.

## PREMIER WINS GLIDDEN TOUR

Chalmers "Thirty" is Second—Mo-  
line Car Holds Chicago Trophy—  
Maxwell Finishes Third in Tour-  
ing Car Class.

CHICAGO, Ills., July 2.—Moline  
car No. 22 today holds the Chicago  
trophy of the annual Glidden tour.  
It was declared the winner of the  
1910 tour, the report of the technical  
committee showing a penalty of 19  
points against it, while the next best  
competitor, Maxwell 107, had 51  
points against it. The Moline 102  
was awarded third place with 44  
points and Moline 101 took fourth  
place with 481 marks.  
Premier car No. 1, Ray McNa-  
mara, was awarded first place in the  
touring car contest. There were 88  
points against the car. The Chal-  
mers "30" was given second prize  
with 116 marks against it.  
The Moline No. 10 won the Chi-  
cago trophy.

## BIG GAIN IN BANK DEPOSITS

Fifty Per Cent Gain in Year Ending  
June 30 and \$200,000 Increase in  
Past Three Months, Despite Fact  
Farmers Are Drawing Heavily.

In spite of the fact that the past  
quarter has been the one in the year  
when bank accounts of local depos-  
itors are more likely to be depleted  
than increased,—that is, those de-  
positors who are engaged in farm-  
ing or orchard growing—the sum to-  
tal of deposits in the several banks  
shows an increase of nearly \$200,000  
over that of March last, and 50 per  
cent gain over a year ago.  
At the close of business March 29th  
the total deposits were \$2,226,584,  
and on June 30 they had grown to  
\$2,573,548.  
Next quarter will see a bigger in-  
crease in the deposits, as by that time  
the returns from fruit and other  
crops will have commenced to come  
in. Still \$200,000 increase isn't bad.

## MANY DIE FROM HEAT IN CHICAGO

Fifteen More Deaths Reported To-  
day, Making Sixty-five From Hot  
Wave—Five Deaths in New York  
City—Trains Crowded With People  
Fleeing From Cities

CHICAGO, Ills., July 2.—Fifteen  
more deaths from heat occurred to-  
day, making a total of sixty-five  
since June 14, when the heat wave  
first struck the city. The thermom-  
eter reached 90 degrees today as  
compared with 92 degrees yesterday  
but there was not enough breeze to  
move a pall of smoke that hung  
over the city. The fact that today  
was a half holiday probably saved  
the lives of many workmen.

NEW YORK, July 2.—Trains  
leaving New York are jammed with  
people fleeing to escape the severe  
heat that has gripped New York for  
the past few days. Fifty thousand  
persons sleep on the beach at Coney  
Island last night. The temperature  
at 85 degrees during the night and  
today there is no prospect of re-  
lief.  
Five deaths and numerous pros-  
trations have been reported.

## GREAT HAVOC WROUGHT BY CANADIAN FIRES

PORT ARTHUR, Ontario, July 2.—  
Forest fires which are raging to-  
day destroyed all but one house in  
the town of Grosie and it is report-  
ed that there were some fatalities.  
Farmers have abandoned their homes  
in the district enveloped by the fires  
and the women and children have  
been brought here.  
Not a building remains in Fort  
Devlin. It is believed Lavalee will  
be saved. The inhabitants have  
fought the flames unceasingly for  
two days and nights.  
The railway losses in the burned  
areas are estimated at \$1,000.

## ALASKA COLONY SETTLES HERE

An Alaska colony is being estab-  
lished in Medford and it gives prom-  
ise of becoming quite a factor in so-  
cial life. W. A. Barnhill, deputy  
United States attorney of Juneau,  
who won fame in politics, is one of  
the pioneers. He plans to leave the  
land of cold and gold, and locate  
permanently here and to this end  
will open an office and practice law.  
Allen Shattuck, also of Juneau, a  
son-in-law of the late Governor  
Stemford, is another colonist. Yester-  
day he purchased the old White  
orchard in Griffin Creek district pay-  
ing \$15,000 for the place, and fol-  
lowed it up with the purchase of the  
Murray residence at Eleventh and  
Laurel streets for \$3,500. Both deals  
were made by the Jackson County  
Realty Company.

## \$75,000 IS WAGERED UPON BIG FIGHT

CHICAGO, Ills., July 2.—Bet-  
ting on the Jeffries-Johnson fight has  
become faster in Chicago. A wager  
of \$75,000 at 10 to 7 on Jeffries has  
been made. A hundred thousand  
thousand dollars from Canada has  
been received to be wagered here.

## MEDFORD WILL ENJOY QUIET 4TH

Small Sale of Fireworks Indicates  
Sane and Safe Observance—Cele-  
brations at Jacksonville, Woodville  
and Butte Falls—Many Picnics  
and Fishing Trips Planned.

Most Medford people are planning  
a sane and safe fourth. The sale  
of fireworks has been small and  
there will be comparative quiet as  
compared with previous years. Cele-  
brations are to be held at Jackson-  
ville, Woodville and Butte Falls, and  
all of these will be largely attended  
from Medford and other valley  
towns.

Jacksonville has prepared for the  
most elaborate of the celebrations.  
The city is well decorated and the  
usual program of baseball and ath-  
letics will be carried out. Hon. C.  
M. McArthur of Portland will be  
the orator of the day. Fireworks  
will make the night brilliant.

Woodville promises all a gay time  
at her celebration. The Central Point  
band will furnish the music and there  
will be baseball and other features.  
Butte Falls offers much the same  
program.

Many Medford people will spend  
the day on the Rogue and other  
streams picnicking and fishing. Quite  
a number have gone to Colesine,  
while several trips to Crater Lake  
will be undertaken.

## RAISED COIN FOR HIGHWAY

Members of Crater Lake Road Fund  
Hustlers Return From Portland  
Reporting Moderate Success in  
Their Efforts.

President W. M. Colvig of the  
Waterman and F. Osenbruge re-  
turned to Medford Saturday after a  
week spent in Portland working for  
the Crater Lake Highway subscrip-  
tion. They brought back a goodly  
sum as the result of their efforts.

"It is slow and hard work rais-  
ing this fund," stated Judge Colvig.  
"It is going to take considerable time  
to secure any appreciable amount.  
Business men are generally friendly  
to the movement, but they have many  
calls upon them, and it is necessary  
to waste a great deal of time in ex-  
planations and visits.

"Every business man in Medford  
should make it a point to solicit those  
from whom he buys as well as per-  
sonal acquaintances in the metropoli-  
s. In this way a considerable  
sum can be secured. We got many  
of the people to subscribe, but it  
is difficult for strangers to get  
money from strangers for a project  
located in a remote part of the state,  
no matter how much it may benefit  
the state.

"People of Portland are very lib-  
eral and broad and when properly  
approached respond liberally, but  
as I said before, solicitation is slow  
and takes time."

## NO BAIL GOES IN ROSEBURG

Constable Wires to Hold Prisoner—  
No Bail to Be Accepted—Uttered  
Bogus Check—Case in Medford  
Settled.

Clarence E. Young, who was in  
edford several weeks ago as a rep-  
resentative of the "Pacific Home-  
land" at Salem, and who had left  
trail of bills of more or less neg-  
ligence in his wake from Salem south,  
under arrest, on information from  
Roseburg, for the same offense he  
was accused of her—issuing checks  
where he had no funds—or, ineffect,  
obtaining money under false pre-  
tenses.  
Young on his former trip here had  
run a good sized bill at The Moore,  
which he liquidated with a check.  
The check was not honored and the  
management, after locating him in  
Salem, had him arrested and re-  
turned here. He made a satisfactory  
settlement of obligations in this city,  
but was almost immediately re-ar-  
rested on telephonic information  
from Roseburg.  
Constable Singler wired the Rose-  
burg authorities of the arrest, say-  
ing that the prisoner wanted to  
know what bail would be required.  
The answer he received was:  
"Hold Young. No bail. Will be  
there on 19 Wright."

## BETS 300 ACRE FARM ON JOHNSON TO WIN

MONTREAL, Que., July 2.—A  
300-acre farm on Johnson to win in  
ten rounds is the latest offering of  
the fight fan. Dr. T. Lovett publishes  
the offer. The farm, he says, is  
worth \$16,000 and he wants to wager  
it at 2 to 1 on the black man's ability  
to knock out Jeffries within ten  
rounds.
