COLONEL HAS "OLD GUARD" WHIPPED TO A FRAZZLE

Republicans of New York Are Now Seeking Compromise With Roosevelt to Ask Him Not to Push Issue of Temporary Chairmanship of Convention at Saratoga.

SARATOGA, N. Y., Sept. 26.—That the "old guard" New York republican leaders have been defeated is admitted today in the plans being made for a conference with Colonel Roosevelt asking a compromise.

Colonel Roosevelt will reach Saratoga late this afternoon. Lou Payne, one of the "old guard" leaders, will, according to present plans, be one of the first callers to greet the former president. Payne will ask Roosevelt not to force the issue of the temporary chairmanship, saying that to oust Vice-President Sherman will be to injure the party in the state and cause an unbridgeable gulf in the ranks of the voters. It is not believed that Roosevelt will comply with their request.

Sherman, it is understood, has notified the leaders of his faction that he will stand pat, and if Roosevelt forces the issue, will await the results of a test vote which will be taken before the temporary organization of the convention at noon tomorrow. Just what the test vote will be on has not been decided, but it is decided that it will be a point which shows the attitude of the delegates. If it is shown that the Roosevelt delegates control, it is believed that Sherman will withdraw as temporary chairman. "It is believed that Roosevelt must take the responsibility for the fight here, not only for today and tomorrow, but for generations to come," said Payne today.

CRIPPEN THE SENATORS INVESTIGATING ELECTION OF LORIMER

Representative White Was First Witness Called and Testified That He Received \$1000 to Vote for Lorimer—Chicago Tribune, Who Conducted Fight, Represented by Attorney.

CHICAGO, Sept. 26.—The senatorial investigation of the indirect charges that a bribery fund was used in electing William Lorimer to the United States senate, began today. Senator Bulkeley of Connecticut joined the committee today and Senator Frazier of Tennessee will arrive tonight.

Representative Charles A. White, who at the two trials of Lee O'Neil Browne, minority leader of the lower house of the Illinois legislature, testified that he received \$1000 to vote for Lorimer for senator, was the first witness.

The Chicago Tribune, which first published White's charges, was represented by Attorney Alfred Austin, who clashed frequently with Attorneys Elbridge, Hancey and O'Donnell, representing Lorimer, over White's testimony before the committee.

White repeated his statements made at the Browne trials, and recited his alleged conversations with Browne regarding how much money he would get. This testimony was objected to by Lorimer's attorneys as calculated to delve into the details of the "jackpot," a fund alleged to have been created for the purchase of votes.

The committee retired to consider the objections of counsel.

In his testimony, White said that he considered the whole amount he received a "jackpot" and that it included the payment for his vote for Lorimer.

AVIATOR FALLS.
PARIS, Sept. 26.—Aviator Lorian, who attempted to fly from Paris to Brussels, carrying one passenger in his aeroplane, lost control of the machine at a great height and both men were hurled to the ground, miraculously escaping serious injury.

The accident occurred at St. Quentin, half way between Paris and the Belgian capital. Lorian was operating a biplane and after the machine capsized it fell like a plummet and was smashed and torn when it struck the ground. The aviator and his companion were removed from the wreckage, suffering only from shocks and slight hurts.

AVIATOR WHO DARED ALPS WILL RECOVER
DOMODOSSOLA, Sept. 26.—Fear that George Chavis, the aviator who flew across the Alps last week for the first time in history and who fell with his machine near Domodossola, will not recover was expressed today by physicians attending him.

A consultation of physicians has been hastily called and Chavis' condition is reported critical.

When the accident occurred Chavis was believed to be fatally hurt. He was taken to a hospital and revived and it was said he would recover. News of his relapse occasioned much regret, as people here were enthusiastic over his feat.

BOWERMAN PLURALITY OVER 3600

Hawley Beats Mulkey by 1700 to 2000 Votes—Kay Nominated for Treasurer Over Hoyt—Insurgents Win Practically All of the State Offices.

PORTLAND, Or., Sept. 26.—Though Jay Bowerman, assembly candidate for governor, undoubtedly secured the nomination in Saturday's primaries, and Congressman W. C. Hawley, standpatter, probably was renominated, the insurgent faction of the republican party succeeded in nominating one congressman and practically all its candidates for the other state offices, according to incomplete returns today.

Ellis Beaten.
Indications are that Congressman W. R. Ellis, standpatter, in the second congressional district, has been beaten by A. W. Lafferty, who made his campaign on insurgent principles. Lafferty's lead today was approximately 3000, with only a few more districts to hear from. Summing it all up, the assembly was beaten and the attempt of the old guard to nullify the direct primary law met with a poor reception.

With practically two-thirds of the primary vote counted, Bowerman's plurality was 3600 over Grant B. Dimick, his nearest opponent, while Ernest Hofer of Salem and Albert Abraham, all anti-assembly candidates, ran third and fourth, respectively.

It is not believed that more complete returns will change the positions of the various candidates in the race.

Kay for Treasurer.
Rolph Hoyt, assembly candidate for state treasurer, has been beaten by T. B. Kay, insurgent, while Governor Benson, assembly candidate.

HOBO HAS A NARROW ESCAPE

Twenty-six Freight Cars Pass Over His Body—He Is Uninjured, But His Escape Is Considered Miraculous.

Twenty-six freight cars passed over the prostrate form of an unknown hobo in the Medford yards last Saturday night and never injured a hair. The Weary Willie had made a flying leap for the bunker of the engine, had slipped and fell underneath the train.

Whether that inborn weariness of tramp nature or a cool presence of mind held him rigidly to the track is not known, but there he remained as the long train passed over him. The inclination is to jump from beneath the train, and seldom in the annals of railroad tragic history has a man laid still and thus escaped death.
