A new line of advertising and general publicity work to be carried along the lines followed by the great commercial bodies of Portland, Los Angeles and other cities, was discussed. Manager Malhotra made a most interesting report upon the splendid condition of the club at the present time, and indicated that according to the results now being obtained the prospects for 1911 were the most glowing in the history of the club's splendid success.

"The state department has no right to order any such thing," said the attorney today. "Italy's refusal to return prisoners wanted here voids the treaty and it is no longer binding. The power to make laws does not lie with Secretary Knox or even with the president. Congress alone has a right to do that."

"We lay our case before the United States circuit court, and if that tribunal decides against us we will carry it to the highest court in the land. We are also going to renew our fight to prevent Charlton being judged insane."

Will Try Habeas Corpus. Habeas corpus proceedings will be taken before the circuit court to prevent extradition. The questions of Clark will bring into the case will attack the treaty under which Secretary Knox has decided to order the extradition. The case will be based on the plea that the state

department has no right to act under a treaty which is non-existent, and it will be contended that the action of Italy in refusing to extradite prisoners to the United States was the virtual annulment of the treaty, and that it therefore no longer exists.

Insanity Questioned.

The question of the insanity of Charlton will be brought in as a subsidiary matter, but it will be made strong enough, it is intimated, to keep the prisoner in America, even if the plea that the treaty is void fails.

The fight will involve some peculiar points of law and a number of international questions.

The habeas corpus proceedings will directly attack the findings of the secretary of state, who, in his order for the extradition of Charlton, said that the refusal of Italy to surrender her subjects to the United States does not relieve this country from the obligation of the extradition treaty. The United States, according to Knox, has by its own actions held the treaty not voided by the action of Italy.

"The United States," said Secretary Knox, "although consistently contending that the Italian interpretation of the treaty was not a proper one, has not treated the Italian practice as a breach of the treaty obligation, necessarily requiring abrogation, has not abrogated the treaty, nor taken any steps looking thereto."

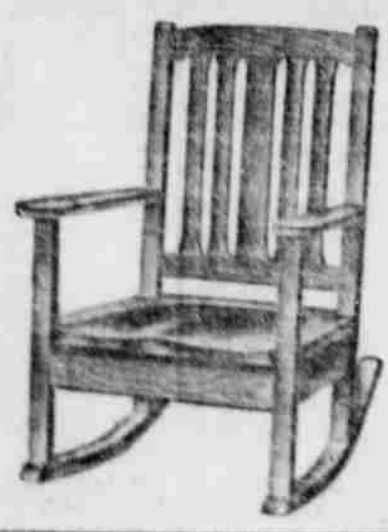
