

REFUSES TO BUY JOSEPHINE DITCH

George E. Sanders of the Chicago Rogue Company Declines Offer to Pay Actual Construction Cost of Ditches.

GRANTS PASS, May 25.—George E. Sanders, representing the Chicago-Rogue Company, has refused the offer made by President H. L. Gilkey of the Josephine County Irrigation and Power Company to sell the latter's irrigating ditches for \$35,000.

Mr. Sanders states: "The Golden Drift plant is now nearly ready for operation, and we would much prefer to have you immediately put the Grants Pass ditch in repair to carry water, and also complete the construction of the Fruitdale ditch. This work is very imperative, as it will require about thirty days to put the ditch in a condition to serve the farmers this season.

"As an alternative, will say that we are willing to buy your ditches at the actual cost of construction work and pay for same in some convenient negotiable security that can be converted into water payments, and will take such securities for 50 per cent of any water payment cash year. In this way the entire cash investment of your stockholders would be returned to them. This offer is made on the premise of an existing contract between your company and the Golden Drift Mining company, as the ditches have very little value to us, or to any one else, without a recognized source for a water supply.
