WASHINGTON, D. C., May 27.—Intimation that within ten years the red flag may be seen on Pennsylvania Avenue, which was made here by Senator Cummins of Iowa, is today causing discussion here as the most plain expression by any member of congress since the conflict between capital and labor began.

SALEM, Ore., May 27.—W. Cooper Morris today served his first day of a six year sentence in the Oregon penitentiary for the part he played in the wrecking of the Oregon Trust and Savings Bank of Portland, of which he was cashier.

The prison door clanged behind the banker only after he had fought for months for liberty and his friends, including prominent jurists, politicians and business men had appealed to the governor for clemency. Governor West, however, after consider-

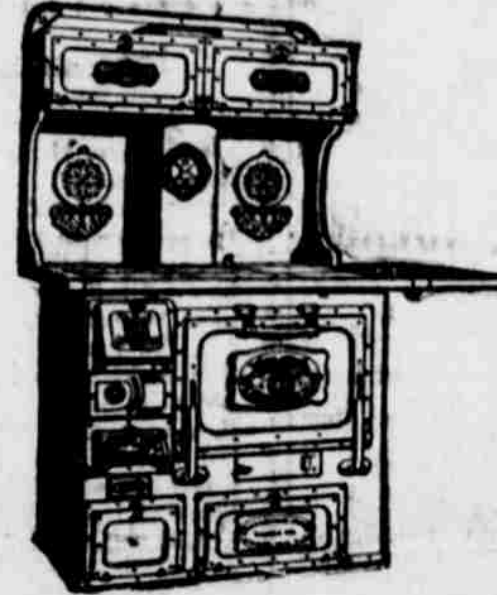
Superintendent James of the penitentiary said that Morris will not be put to work for the present.

CLASS TOO BIG FOR QUARTERS

Methodist Sunday School Forced to Use Tents in Which to Conduct Classes—Nearly 500 Students Attend School Regularly.

Time was when the Methodist Episcopal church could easily supply the necessary space for all attending Sunday school scholars, but that was in days long gone by, and now they are but a memory. The present enrollment of this Sunday school is between 400 and 500 and the regular attendance is fully 400. It has become necessary to secure class rooms elsewhere than in the church and the church basement. Two at least of the classes are occupying large tents on the church grounds, while other teachers who live near by take their classes to their homes and there inculcate in the minds of their young flocks the principles of an honest, earnest and faithful Christian life. Especial interest at this time is centered in the work of the men's class, Mr. Steep, teacher. This class meets in a large tent, which has a seating capacity of 80 or more, and nearly this number is in attendance every Sunday. The class is composed of men whose ages range from 20 to 60. The lesson for today is "Micah's Picture of Universal Peace."

This is intended as an international peace lesson and will be handled by the class upon lines calculated to instill in the mind the great benefits which would accrue, both in a Christian and a commercial sense, were it possible to establish and maintain a peace treaty among all nations of the world.

FINDS GOOD STONE HERE

While in the Rogue River Valley Mr. Doyle did some extensive prospecting for the Portland Cement Company, and on his way north examined the Phoenix quarry and the Cooper Sandstone's old quarries near Roseburg. In speaking of the mineral resources of the Rogue River Valley, Mr. Doyle, who is an Eastern mineralogist of some repute, is well pleased with what he saw in the vicinity of Medford and thinks there are prospects of a large granite trade.
