

HATCHERY UNDER WAY AT FISH LAKE

Men Come Out From Umpqua Divide To Purchase Supplies—When Eggs Are Eyed They Will Be Taken On Pack Horses to Elk Creek.

H. I. Jewell, in charge of the government fish station now being constructed at Fish Lake at the head of the north fork of the Umpqua river 25 miles north west of Crater Lake was in Medford Monday and Tuesday, purchasing supplies and getting a net to be used in catching the fish.

Mr. Jewell with six assistants went to the mountains ten days ago and established a camp. Returning from Drews the trip to Medford required four days travel as the trails are wild and used very little.
