

# PREDICTS FAME FOR MEDFORD

Dr. George N. Taylor to Deliver His Famous Lecture Sunday—Says the City Should Be Known for Its Good Men and Women.

"Along with Hood River, Yakima and Wenatchee, Medford will be known far and near," remarks George N. Taylor who has been invited to give his address "God's Work for Today's Men," at the Presbyterian church Sunday morning at the 11 o'clock service. Dr. Taylor adds that Medford will have a large population and that her church people will find their opportunity here.

"Let Medford also be known as a city where the church folks set a pace in sounding the gospel message. You're two hundreds miles of mountain panorama that marks the horizon are good to look at and a people famous for their devotion to the highest, spiritual task will be a further crowning glory in keeping with the splendid enterprise of the valley."

Mr. Taylor is one of those who believe that the Christian businessman is the answer to the question of church life of today. "If the Master were to return to earth," he remarks, "and would point to his command, 'Go ye with the message' and also point to Dun's or Bradstreet's book of commercial ratings, He would need to say no word. The 'go ye' enterprise halts today for lack of money and Dun's shows that the Christian business men hold the millions of wealth."

Mr. Taylor sees great promise in the splendidly organized Bible classes of Medford's churches.

"Experienced workers of other fields are in Medford in force," Mr. Taylor continues. "Their church letters lie in trunks or to be sent for. Let these renew old vows, back the pastor and present faithful workers. More Bible classes, new faces and a happy crowding out of present quarters must follow."

"A big crop of pears from the valley is a splendid harvest. Let Medford also send out young people who have been brought up in the atmosphere of devotion to high work."

## TAFT WAVERS ABOUT WILEY

May Advise Wilson to Get Rid of Solicitor McCabe, the Legal Adviser Who Curbed Pure Food Specialist Instead of Litter.

WASHINGTON, D. C., Aug. 19.—Opinion is strong here today that President Taft is wavering in his determination to reprimand Dr. H. W. Wiley, chief chemist, and instead will advise Secretary Wilson to get rid of Solicitor McCabe, his legal adviser, who curbed the pure food specialist. If this happens, the president will likely turn the enforcement of the food and drugs act over to Dr. Wiley, unless stopped by protests from the dried fruit and wine interests of California.

Owing to his previous decision, those industries in which sulphur must be used will have to suspend, if Wiley wins out.

The president, reports indicate, has been influenced by misleading reports by the press. Secretary Wilson is going on the stand Monday to show that Wiley has not been truthful. He is going to put into the record Dr. Wiley's decision that inasmuch as glucose is made from corn, it is really corn syrup, and that he wrote a reply to Dr. Wiley's request for a hearing, although the doctor told the committee that the secretary had not answered his report. Wilson's statement probably will close the hearings.

## AVIATOR BRINDLEY SOARS 11,726 FEET

CHICAGO, Aug. 19.—Oscar A. Brindley soared higher from the ground today than any airplane has ever been before and set a new world's record at 11,726 feet. Philip O. Parmelee followed him in the air, passing the former American record and reaching 10,837 feet. The world's record of 10,761 feet was made by Loidan at Maumelon, France, July 8 last. Captain Felix flew to a height of 11,152 feet at Etampes, France recently, but his flight has not yet been made official. Ralph Johnstone held the American record made at New York October 3, 1910, at 10,476 feet. Arch Hoxsey ascended more than 11,000 feet the day he was killed but his barograph was shattered in the fall and the official test as to accuracy could not be made.

## TOWN OF BAY CENTER DESTROYED BY FIRE

SOUTH BEND, Wash., Aug. 19.—The little town of Bay Center, 10 miles from here, was almost wiped out by fire early today, with a loss estimated at between \$50,000 and \$75,000. The fire started in the merchandise store of Park Anderson and spread rapidly to the Bayview hotel, postoffice and other buildings in the business section. A high wind drove the flames into the residence section where several houses were consumed despite the hard work of volunteer firemen.
