STANFORD SPIRIT MAY FOOL 'EM

University of California Is Picked to Win This Season's Big Football Game—Berkeley Wins From Vancouver Team.

BERKELEY, Cal., Oct. 26.—The remarkable reversal to their true form of the University of California rugby team which swept the blue and gold to a splendid 21-0 victory over the "All British Columbia" champions, is the talk of the campus today, and a sure defeat is predicted for Stanford when the varsity takes its biennial jaunt down to Palo Alto next month.

For the past month in various practice games the California team had shown miserable form, the veteran backs fumbling the ball as frequently as the new recruits. The same slipshod playing was apparent in the game against Vancouver throughout the first half, and then, in some unaccounted for manner, the entire back division of the blue and gold started working smoothly together and bore down the opposition like chaff.
