

M'MANIGAL TELLS SAME OLD STORY TO GRAND JURY

Testimony Before Federal Official
Inquisitorial Body Said to Be
Identical With One Told Earlier to
William J. Burns.

OVER 130 WITNESSES
CALLED BY UNCLE SAM

John J. McNamara Says They Might
as Well Take Him North, for
He Will Not "Squeal."

LOS ANGELES, Cal., Dec. 8.—When the federal probe into the alleged dynamiting conspiracy was continued today the government had waiting to testify a score of witnesses who were to follow Orrie E. McManigal and carry out the threads of corroboration of his story of operations with dynamite and torch. McManigal was still on the stand, and it was stated that his story is almost a duplicate of that which he told before the county grand jury which indicted the McNamara brothers, with the exception that names and details suppressed then are now coming out.

No word has yet been received by the federal marshal here whether the officers in San Francisco and elsewhere have succeeded in subpoenaing the labor chiefs who are to be examined here. Those men include J. E. Munsey of the Ironworkers' Union at Salt Lake; E. A. Clancey, John A. Kelley, Andrew J. Gallagher and Olaf A. Tveitmo, of the San Francisco labor council.

McNamara Not to Talk.

Assistant District Attorney Reagan and the government agent in charge of the prosecution had not made up their minds regarding the McNamaras today. They became angered when asked whether a direct offer of material concessions regarding their terms of imprisonment had been made and rejected over night. It is known, however, that John J. McNamara told his jailers today that they might as well take him north, as there would be no squealing.

It is known that in discussing the suggestion that if he "came through" as the government desires he would either get a pardon or at least material concession the shape of having his sentence cut short, J. J. McNamara said that while this might be so, some of the men who were now so bitterly denouncing him would have an easier task of getting him out of the way while he would also be known as a "squealer." So he insists that he is determined to say nothing.

130 Subpoenas.

That the government probe will be lengthy is shown by the announcement that 130 subpoenas are being served by United States marshals in the various states of the western Pacific slope. Every effort is to be made to guard the identity of the witnesses, and the men indicted will not be known until the documents are actually handed up in open court.

So far as the state is concerned, its case is in the doldrums. Until the Franklin bribery examination begins Monday the attorneys associated on both sides of the McNamara case will remain in seclusion. Frederic has gone back to the regular routine of the district attorney's office, and his chief assistant, William J. Ford is getting in witnesses together for the Franklin hearing. Darow, Davis and their associates continue the offices in the Higgins building but have very few callers. They admit they do not know what will be done in the Franklin case and until it is disposed of they will maintain their attitude of refusing to discuss the various allegations by organized labor in the east that they deceived them about the McNamaras from the start.

LABOR LEADER IN FRISCO SERVED

SAN FRANCISCO, Cal., Dec. 8.—United States Marshall Elliott here today served a subpoena upon E. A. Clancey, a local union labor leader, alleged to have been involved in the McNamara cases, ordering him to attend the federal investigation into the dynamiting cases at Los Angeles as a witness.

Clancey is ill at his home here. The marshal refused to say whether he had subpoenas in hand for any of the other union labor leaders named in the connection with the McNamara probe.

MORE GRAIN IS BEING PLANTED

Nearly Every Orchard Man in Valley
Is Buying Seed With Which to Sow
Land in Between Their Young
Trees.

It is a noticeable fact, and a commendable one, that a far greater number of the orchardmen and farmers of the valley are seeding more land to grain this fall than they have put out for a number of years.

The local grain dealers of Medford report that nearly every orchardman in the valley is buying seed grain this fall, the grain to be sown in nearly every instance between the tree rows of their young orchards.

Not all the orchardmen are sowing grain between the tree rows but it would be safe to state that there are more of them who are not expecting to plant something between the tree rows, either grain now, or later in the season corn and potatoes.

VOTE ON SALARIES FOR THIRD TIME

In spite of the fact that Ashland voters have twice turned down, within the past year, the proposition to pay the mayor and councilmen a salary the matter is to be voted on again. 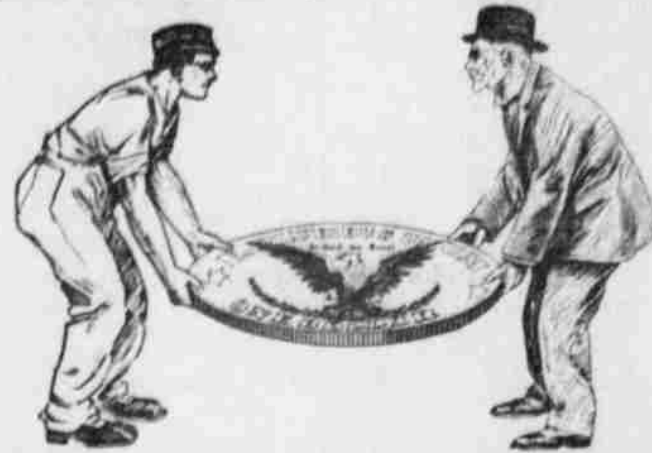
