

### 1500 ACRES OF LAND IS SOLD

Lee H. Wakefield of Anacortes Wash., Buys Tract of Land Lying Eight Miles Southeast of Medford—Price Withheld.

The Dunlap Bros. Thursday sold 1500 acres of land lying about eight miles southeast of Medford to Lee H. Wakefield, of Anacortes, Wash. The price paid for the land is not given out, but is known to be fairly well up into five figures.

The land above mentioned is very much of a nature, some of it being suitable for fruit culture, other parts of it adapted best for pasture land, while underlying those parts of it not considered of any great value for either of the above named pursuits are said to be valuable coal deposits.

Mr. Wakefield and others who are associated with him in the purchase expect to soon commence the development of the tract, both on the surface for the purposes best adapted, and underneath the surface as well, there being very flattering indications of immense coal deposits under the rugged hills on the tract.

#### Eighty-Acre Tract Sold.

Mrs. J. K. Darnell and her son, Chas. Higginbotham, have purchased the Fisher place, one mile south of Tolo and expect to move from Medford to their recent purchase at once.

There are eighty acres in the tract and it is all Bear Creek bottom land. Mrs. Darnell and her son expect to put a good part of the land out to alfalfa at once, and as soon as possible seed the entire tract to alfalfa. This is considered some of the best land in the valley for this kind of crop.

### SUED FOR \$3500 LAND COMMISSION

Ed Hughes Sues Dunlap Brothers for Commission Said to Be Due for Land Sale Near Talent Some Time Ago.

In the circuit court yesterday the suit of Hughes vs. Dunlap Bros., was tried out before a jury and after a deliberation of five hours a verdict was returned for the defendants.

The case grew out of a real estate deal made several months ago where-in Dunlap Bros. sold a tract of land near Talent to the Morse Realty company. The consideration in the transaction was \$75,000, and the defendants paid G. A. Morse a commission of \$3750. Ed Hughes, an Astoria real estate dealer, alleged that he was instrumental in some way in closing up the deal and began suit against the Dunlap Bros. to recover \$3750, the amount he alleged to be due him.

### COURIER OFFICE BROKEN INTO

Heavy Team of Horses Runs Away and Crashes Through Great Plate Glass Window Into Editorial Rooms.

GRANTS PASS, Ore., Dec. 15.—A heavy team of horses hitched to a produce wagon ran a number of blocks in wild fright through the main street of this city here at noon today, and plunged through an 18-foot length of heavy plate glass into the Daily Courier office, with one horse, fat and bleeding, falling at the desk occupied by Miss Louise Birdall. The stenographer girl had just stepped away from the desk, escaping the crash of quarter-inch thick glass which fell over all of the office.

C. G. Coutant, editorial writer, was seated by the glass front, but escaped by making a wild jump for life.

T. E. Hanley, United Press operator, had gone to lunch, which saved him butchery, as his desk was only 12 inches from the crashing glass.

Blood from the wounded horses covered the floor, desks and chairs of the office.
