INTERESTING MEETINGS OF WOMEN'S CLUBS.

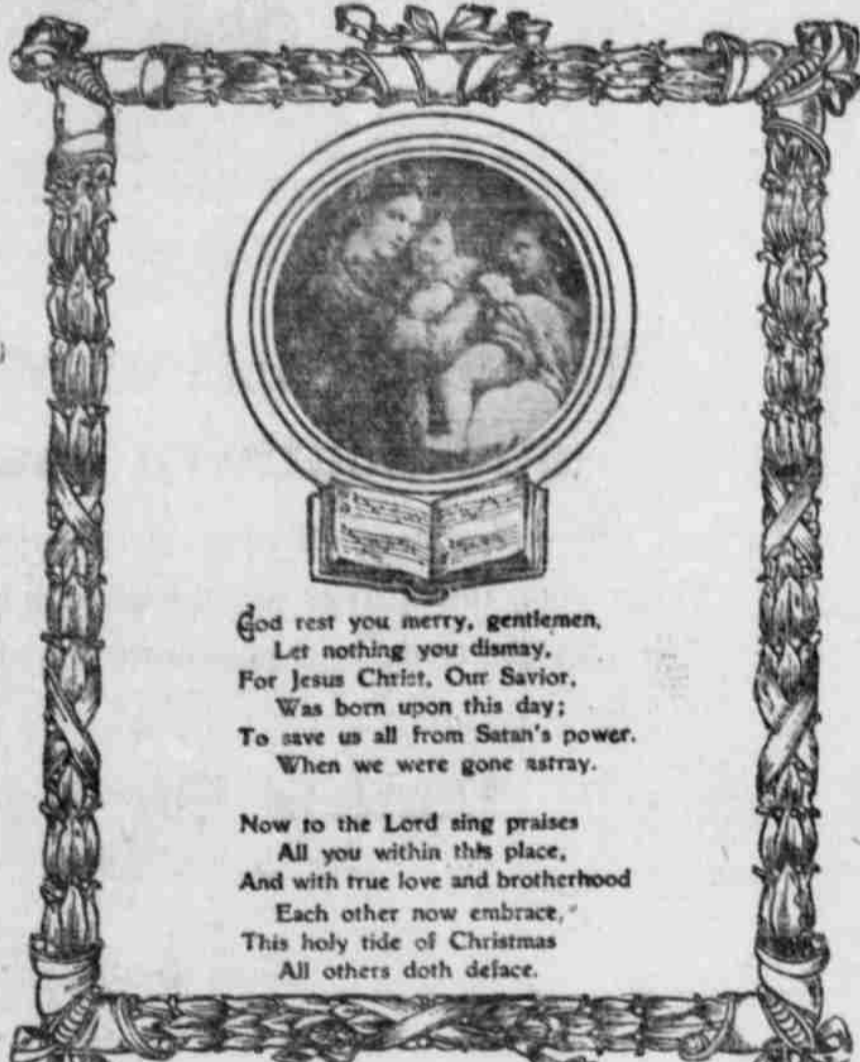
