ITALY MAY SIDESTEP WAR

Sends Note of Apology to France, But It May Not Be Sufficient—France Is in Readiness for Instant Action.

ROME, Jan. 24.—Fearing war with France, Italy today decided to release the 29 Turkish Red Cross nurses captured aboard the French merchant vessel Manouba.

Dispatches from Paris today state that the French ambassador will be recalled, and the French naval commanders had been ordered to prepare for immediate demonstrations on the Mediterranean unless the prisoners are released.

Italy concluded that it was wiser to surrender a few prisoners than engage in hostilities with France. The note followed, but it is not yet certain that the note is sufficiently apologetic to meet the French view.
