

# TAFT IN PACT WITH MAILMEN

Insurgents in Arms Because of Secret Conference Between President and Postmasters of Large Cities—Taft Weakened by Cold

COLUMBUS, O., Jan. 31.—Angered by the discovery that postmasters of the principal cities of Ohio met secretly here yesterday and that many of them conferred with President Taft, Roosevelt boosters today threaten to file charges of political activity against the mail men.

It is reported that at the postmasters' conference plans were laid by which they were to lend active aid to the election of Taft delegates to the republican national convention.

President Taft today was much weakened as a result of speaking yesterday despite his heavy cold. He conferred with republican editors of the state at 10 o'clock today and at 11:30 o'clock briefly addressed the constitutional convention. At 1 o'clock this afternoon he started for Akron.

While the president slept badly last night on account of a hacking cough, Dr. Rhodes declares his condition is not alarming.
