

## TELFER RESIGNS RECODER'S JOB BY JUNIOR CLUB

III Health Given as Cause—Public Market Plans Received—City Hall Extension—Dox Tax Established—Air Tight Garbage Cans Ordered.

R. W. Telfer, who was recently re-elected city recorder, resigned Tuesday evening, giving as a reason ill health and the orders of the physician that he must seek out of door employment. His resignation was accepted by the city council and his assistant, E. T. Foss, was Wednesday named by Mayor Canon to temporarily fill the place. Mr. Telfer has served three years with satisfaction to all concerned.

### Public Market Plans.

Preliminary plans for the city hall addition and public market were submitted to the council and referred to the building committee. The hall contains office rooms for mayor, recorder, engineer, council chamber and firemen. The lower floor contains jail extensions, stables, furnace room, fire hall, etc. The public market will be a frame structure, 40 by 100 feet, covered with sheet metal, containing 24 stalls and rest rooms. Two counters run the length of the building.

### Dog Tax Created.

An ordinance was passed creating a tax on male dogs of \$1.50 and upon females of 83 per year to take effect at once. A dog pound is created and a dog catcher is to be named to collect the tax and kill the untagged canines.

An ordinance provides that all garbage of the city be kept in water-tight cans and removed by licensed wagons, also water-tight, was introduced by City Health Officer Dr. R. W. Stearns at the council meeting last night. The ordinance as read was referred to the health committee.

R. A. Flynn asked in behalf of the Pacific Highway association that the council appropriate \$50 for the maintenance of the signs in this section. The matter was referred to finance committee.

### Water Bonds Issued.

Water main bonds to the amount of \$31,000 were ordered issued.

The Federal Telegraph company asked permission to have wires over the city for the receiving of wireless telegrams. No action taken.

A resolution asking for the laying of a board walk on east side of Summit avenue from Fourth street to Jackson street was referred to street committee.

A petition of the property owners on Fourteenth street to grade said street from Newtown street to King street was referred to the street committee.

Application of J. C. Karnes for a liquor license was granted.

A petition of Doe Ryan to transfer his license to other parties was laid upon the table.

## RURAL ROUTE FROM PASS TO WOODVILLE

Beginning April 1 a daily rural mail delivery from Grants Pass to Woodville and intermediate points on two sides of Rogue river will be inaugurated.

The carrier's salary is fixed at \$960 a year, and a civil service examination will be held at an early date for the purpose of naming this carrier.

This new route will be the third from Grants Pass, and is to be known as route No. 3. The carrier will leave Grants Pass at 8 a. m. daily and return at 4 p. m.

### DON RADER ON TEAM UNIVERSITY OF OREGON

UNIVERSITY OF OREGON, Eugene, Ore., Feb. 7.—Donald Rader of Medford has been chosen as a member of Oregon's strong basketball team. Four of last year's team are in college again this year. Accordingly, only one position was open on the Varsity quintet, and there were over a hundred candidates for it.

Oregon never before has had a basketball team of the class of the present one. Friday night, Oregon defeated Willamette university 47 to 5. On Friday of this week the Varsity team leaves for a tour of the Inland Empire.

### LOCATE QUARTERMASTER DEPARTMENT AT TACOMA

TACOMA, Wash., Feb. 7.—Following a public hearing this morning before General Wood orders were issued cancelling the recent order to remove the United States quartermaster department from Tacoma to Seattle and locating it permanently in Tacoma. Cableships and other government craft are supplied by the local branch.

## WANT PICTURE SHOW CENSORED

Parents of School Children Ask Council That Careful Consideration of Films Be Given—Want Curfew Law Enforced.

The city council has received the following resolutions and referred them to the license committee:

First—Be it resolved, that we, the members of the Washington Parents-Teachers' association, ask a more careful consideration be made of the moving picture film shows in our city, and that a copy of these resolutions be sent to the managers of the several moving picture shows. If this does not have the desired effect, then a board of censorship be appointed to pass on these films.

Second—That an ordinance be passed by the city council prohibiting second-hand dealers from buying from children under age without a written consent from parents.

Third—That the curfew law be enforced.

### DOCTORS LECTURE TO UNIVERSITY STUDENTS

UNIVERSITY OF OREGON, Eugene, Feb. 7.—Something of practical value and interest to the students of the university has been introduced by the Y. M. C. A. in the form of a series of weekly lectures by prominent physicians upon the methods employed in giving first aid to the injured. Last week Dr. E. W. Cummings spoke upon "Dislocations of the Hip, Elbow and Shoulder." He gave valuable hints as to the manner of procedure in such cases and illustrated his points by using Charles Koyle, local secretary of the Y. M. C. A., as a model.

This class has adopted the practice of giving the historical setting as well as the Biblical reference. Applications are also made tending to bring discussions from the members and many lively debates are enjoyed.

President Stine said: "To the organizers Sunday was indeed a joyful day. Two months ago we started the class with the slogan, '100 members.' We gained the goal. Then we planned to have February 4 a '100 present day.' People laughed at us and called it an idle dream. We realized the task, but we conquered. The future is indeed bright."

H. H. Tuttle, who is the teacher of the class, said: "The class has three aims: To live the broader, greater life of practical Christianity; to use it every day in our life; to bring the younger generation to Christ and the church by concrete example and not by oratory or handing out platitudes. Finally, to insure Medford a good, clean, honest government by voting together and taking decided, open stands on certain principles."

There are between 200 and 300 men in the different churches, all associated in this movement, and the classes are constantly increasing.

There is power untold there and 400 votes mean something. But primarily this is not a body politic but a real Christian movement."
