

DROZCO'S CABINET SITS IN LOS ANGELES

LOS ANGELES, Cal., July 29.—That General Pascual Orozco's "cabinet" has set up headquarters in this city and is advising the Mexican rebel chieftain from the American side of the line is the announcement of United States secret service men here today. The men who constitute the advisory board of Orozco, it is claimed, have established headquarters in North Main street, the old Spanish section of the city, and are planning to inaugurate a weekly newspaper to attack President Madero.

The establishment of headquarters here is taken as confirmation of the reported plan of the rebels to abandon Chihuahua, where they have practically been driven out, and concentrate their efforts against the state of Sonora.

THEFT OF REPUBLICAN ELECTORS SAYS HILLES

NEW YORK, July 29.—Charles D. Hilles, formerly secretary to President Taft, now chairman of the republican national committee has issued a statement in which he said "the only possible justification of the avowed efforts of the third term party leaders is to induce the republican electors in at least six states to betray their trust and cast their votes in the electoral college for Roosevelt and that there is no truth in the charge that President Taft was nominated by the fraudulent seating of a sufficient number of delegates to affect the choice of the national convention.

"There is no truth whatsoever in that charge. Colonel Roosevelt and his associates know there is no truth in it but they have been attempting by vociferation and reiteration to belud the fact that they have no proof to offer. They would drown out by the persistent cries of "thief" and "fraud" all attempts to establish the truth.

"The third term party is the confessed sponsor for one hundred and sixty fake contests by which it attempted to secure fraudulent control of the national convention and now has the temerity to ask the American public to believe that in the remaining seventy-eight contests the right was all on its side.

"Of the 238 contests which Roosevelt ordered to be brought before the national committee, his political managers voluntarily abandoned one hundred and sixty-one. His press agents announced these contests were instituted solely for psychological effects in order that a table of delegates elected might not reveal the large majority of legitimately elected delegates instructed for President Taft.

"There is no steam roller in operation, the committee voted in accordance to its convictions and as it was compelled to on the evidence, Roosevelt confessed his own knowledge of the fraudulent character in his contests and testified to the justice of the committee's work, and when at Oyster Bay the night the committee's action was taken he showed to representatives of the press sections of his confidential list of delegates.

"The list showed Roosevelt expected only two of his contesting delegates from Alabama to be seated and Roosevelt added: 'We hadn't counted on any but those two.' Yet he sought to cast a cloud over the title to twenty other votes. 'When you go seeking equity, do equity,' that is an old maxim of equity. The law and jury from which Roosevelt is pretending to seek equity is from the republican national committee and he sought to induce that committee to unseat at least one hundred and sixty regularly elected delegates and in their stead seat Roosevelt delegates whose election he had admitted was fraudulent—admitted it by abandoning the cases either before the national committee or before the time came to present them to the committee on credentials of the convention.

"What would you think of a lawyer who advised his client to bring 238 suits knowing there was no justice, if any, at least in only 78. Would not such a course prejudice the most just court on earth. But that is precisely what Roosevelt's managers did in the case of the republican national committee.

"Why they know their revelation of the fraudulent character of their cases in one contest after another must prejudice the court against them and thus tend to lose any of their cases which possessed merit." Hilles declared the course of the Roosevelt "lawyers" unscrupulous and not seeking equity but seeking political advantage.

POLICE NET GATHERS SUSPECTS IN NEW YORK MURDER CASE



The police net is gathering in many suspects in the sensational Rosenthal murder case in New York city. Five are held without bail, including "Bridge" Weber, "Jack" Rose, "Sam" Paul, William Shapiro and Lewis Libby, the last two named being the owners of the automobile used by the murderers. Weber is the proprietor of a gambling house wherein, it is alleged, the slayers of Rosenthal played cards and had a whispered conference just before the crime was committed. "Sam" Paul was a former friend of the victim and is well known to the gambling element of the lower east side of the town. "Jack" Sullivan, whose right name is Jacob Reich, is known as the "King of Newsboys" and is held as a material witness.

MOVEMENT FOR CHURCH UNDER WAY

A large number of Congregationalists met Sunday morning at the Moose hall and discussed plans for the establishment of a new church of that denomination in this city. A committee was named to ascertain how many Congregationalists there are in this city. The Home Missionary Society of the church has pledged \$750 toward a pastor's salary for the first year and several thousand dollars toward a building fund.

G. O. P. TARIFF BILL PASSED BY SENATE

WASHINGTON, July 29.—A republican sugar tariff bill, the first purely republican revision measure of the present congress was adopted by the senate. Deserting their allies of the last two days, the republican progressives by iron clad rules with the regulars, succeeded in passing a tariff reduction bill which they believe President Taft will sign. The sugar bill was a compromise between the Lodge plan endorsed by the regulars and the Bristow bill, behind which the progressives were lined up. It would cut the present duty of \$1.99 to \$1.60, would abolish the duties standard under which virtually no refined sugar can be imported, and would abolish the 7 1/2-cent "refiners' deferential," an additional duty on refined sugar which it is said has accrued directly to the profit of the refiner.

FURNISHING IMPETUS TO DAIRY INDUSTRY

WEST STAYTON, July 29.—The dairy industry has been given a decided impetus by the action of the Willamette Valley Irrigated Land Company in providing the settlers on the irrigated tracts with funds to buy all the milk cows they can feed, repaying the amounts in monthly installments out of the cream checks.

\$100,000 STATUE OF M'KINLEY

NILES, Ohio, July 29.—The citizens of this city have raised today more than \$35,000 toward a \$100,000 fund for the erection of a memorial to William McKinley. Miles is the birthplace of the martyred president. Yesterday at noon a six days campaign was started to raise the entire sum needed. The \$35,000 subscribed was the result of the first day's campaign.

A meeting of the school children will be held tomorrow and 5000 pupils will join the committee in the work.

KANSAS CITY BALLOON WINS ELIMINATION RACE

KANSAS CITY, Mo., July 29.—With only one balloon, the "Uncle Sam" of the Kansas City Aero Club, unreported, it is believed here today that the Kansas City II, John Watts, pilot, has won the national elimination race which started from here Saturday afternoon. The Million Population Club No. 1, it was learned today, landed near Nora, Ill. The Kansas City II leads so far in the race, having covered approximately 640 miles.

COE IS APPOINTED ON CREDENTIALS COMMITTEE

PORTLAND, Ore., July 29.—Dr. H. W. Coe of Portland is today in receipt of a telegram from Medill McCormick, notifying him of his appointment as a member of the credentials committee that will pass on the qualifications of delegates to sit in the national progressive party convention at Chicago August 5. Dr. Coe was one of the signers of the call for the convention.

WOMAN TRIED FOR SLAYING HUSBAND

ATLANTA, Ga., July 29.—With the court room jammed the trial of Mrs. Daisy Grace, charged with attempting to murder her husband, Eugene Grace, with the alleged motive of securing his insurance money, started here today. Mrs. Grace is confident of acquittal.

In the early morning of March 5 last, Grace telephoned to the police that he had been shot. Arriving at his home they found Grace alone, locked in a bedroom. The bullet caused paralysis from the waist down, and Grace was near death for weeks. When he recovered he charged his wife with shooting him to get his insurance money.

Mrs. Grace, in protesting her innocence, asserts there is another woman in the case.

LIFE TERMER TRUE TO WORD; RECEIVES PARDON

WARDNER, Idaho, July 29.—Governor Oswald West's plan of prison reform has worked out advantageously in the case of Billy Mack, a miner, employed in the mines here. The man was sentenced to the Oregon penitentiary for life, but when he showed himself a man was granted a pardon.

The mortgage hanging over the home of his wife's parents, caused by the efforts of the family to save him from prison, was the cause of the pardon. Mack appealed to the governor and was given a parole. He set to work and found employment in a blacksmith shop, where he was faithful, and soon raised \$200, enough to lift the mortgage on the place of Mr. and Mrs. Sam P. Wilson, formerly of Wardner.

The prisoner then returned to Salem and reported to the warden and started serving the remainder of his endless sentence. It was because he had made good and had kept his promise with Governor West that he was soon liberated, a full pardon coming to him.

Mack's wife remained loyal to him, and before he returned to prison he secured a position as cook for her in a logging camp, where she was certain to make enough to keep herself and their two children.

The crime for which Mack was sentenced five years ago was committed at Grants Pass, Or. Mack engaged in a quarrel with two bartenders in a saloon and was thrown into

WILSON FINISHES ACCEPTANCE SPEECH

SEA GIRT, N. J., July 29.—With his speech of acceptance of the democratic presidential nomination completed, Governor Woodrow Wilson will return here tonight.

Information received of what Governor Wilson will say is that his speech will be strongly progressive in tone. Wilson favors tariff for revenue only; scientific tariff reduction, and heavy taxation of luxuries. He will urge that there be no third, and even no second term for presidents. Regarding the trusts, Wilson favors the proposition that all trust officials convicted of violating the Sherman law shall be dealt with on the basis of personal guilt. His speech also will favor direct primaries and a drastic national corrupt practices act.

Governor Wilson will go to Trenton tomorrow to transact state business. Wednesday he will confer with the leaders of the democratic party to make plans for the national campaign.

COUPLE START HONEYMOON IN PRIZE BALLOON RACE

KANSAS CITY, Mo., July 29.—Seven huge gas balloons ascended from the aviation field here Saturday in a race to determine what three shall journey to Stuttgart, Germany, to compete this fall with the foreign sportsmen in an effort to regain for America the James Gordon Bennett trophy lost last year. The German balloon won the international race. The pilot balloon Kansas City III, carrying Dr. Milo E.
