MEXICAN REBEL CHIEF DEMANDS REMOVAL OF PRESIDENT MADERO

Emiliano Zapata, the Mexican rebel chief, who is threatening to attack Mexico City, makes charges against President Madero, demands the latter's resignation and requests that the President and his entire family leave the Republic forever. Gen. Zapata also demands the expulsion of Ernesto Madero, Minister of Finance and uncle of the President. Zapata declares that he is not seeking the Presidency, but insists that the present policy of oppression in Mexico must cease. The rebel leader has 18,000 men under arms and says he will use them to enforce his demands.

TO FIGHT FOR MILLIONS LOST CENTURY AGO

PORTLAND, Sept. 24.—Herman Rietveld of Portland today prepared to fight for a share of the treasure valued at more than \$6,000,000 now being recovered in the Zayder Zee from the submerged wreck of the British Frigate Lutin which was lost in a gale more than a century ago. The treasure is in gold bars and coin. Rietveld asserts he is a direct descendant and heir of Henry W. Van Dam, of Amsterdam, to whom the lost treasure belonged.

RICH MARRIED TO FIRST WIFE SAYS RABBI

GRANTS PASS, Ore., Sept. 24.—Meyer S. Levy, rabbi of Congregation Beth Israel, San Francisco, has wired the district attorney here today that on August 18, 1907, he married Nora Cohn and Lawrence B. Rich under the laws of the state of California and according to the Jewish customs. Rich is still held in the county jail awaiting action of the grand jury, now in session here. Rich denied his marriage to Miss Cohn, claiming his marriage to Miss Jessie Layton here last February was legal. The charge against him is polygamy.

NEW ORLEANS, La., Sept. 24.—Suffering qualms of conscience for having deprived John D. Rockefeller of even the smallest part of his wealth, a young son of Dr. Thomas Dunne of New Orleans today in a letter asked the oil king's permission to keep a penny found on the Rockefeller estate during a visit to Cleveland. Young Dunne is anxiously awaiting a reply.

DOCTOR TRIES TO KIDNAP GIRLS

SEATTLE, Sept. 24.—Telling a story of their attempted imprisonment in a lonely house on the Richmond Beach road, by a young "doctor," two department store girls this morning swore out warrants against him, and deputy sheriffs and police are today guarding against his escape from the city. The girls accepted his invitation late Saturday night for an automobile ride. They stopped at what they thought was a roadhouse for refreshments. The house, however, was deserted except for the three of them, and it soon became apparent, say the girls, that the doctor meant violence. Their cries were in vain and the doors were securely locked. One of the girls, however, seized an opportunity and escaped through a window yesterday. She telephoned the sheriff's office. The doctor, becoming alarmed made a quick get-away.

His name is given as L. R. Lawson, and he is believed to be connected with a local "medical institute."
