

## BOSTON WINS FOURTH GAME, SCORE 3 TO 1

### RED SOX LEAD NEW YORKERS BY ODD GAME

Both Teams Play Great Ball and Boston Secures Deserved Victory, Though Outlit by Giants—Smoky Joe Wood and Wagner the Heroes.

Stonewall Defense of Red Sox's Infield Feature of Game—Teereau Also in Good Form.

NEW YORK, Oct. 11.—Joe Wood repeated on Teereau and the New York Giants today, and as a result the Boston Red Sox returned to Beantown tonight with the "jump game" once more in their possession and the Giants one down.

"Smoky Joe" Wood, with a gray day to help him out, was all there with a margin to spare. Teereau was good but not good enough to cope with the gilt-edged product of the Boston marvel. Wood's effort was unquestionably a big factor but no small share of the credit for the win must go to a ballplaying centipede by the name of Heinie Wagner.

#### Wagner's Brilliant Work

The count was 3 to 1 and but for Wagner's brilliant, almost superhuman work the Giant attack would have left a different story to be written of Wood's day's efforts.

For four rounds Wood worked at top speed, driving the Giants to the soup trough almost in order. He had them corbed at every turn. In the fifth the Red Sox premier pitcher, worked to a raw frazzle, began to break and threatened to crumple up. Merkle slashed one over second and by a great stop Wagner cut down the hit. Herzog singled and Fletcher cracked another over second, where the flashing Wagner again cut over and by a hair-raising stop and throw the rally was killed.

#### Defense Brilliant

All through the closing stages of the game Wagner and Yerkes stood back of Wood, who, pitching game—

### TAXI DRIVER SAYS ONE MAN SHOT ROSENTHAL

NEW YORK, Oct. 11.—Aiming their guns at the damaging testimony given by Louis Kraus, a waiter, who swore that Gambler Herman Rosenthal was shot down at a signal from one of the conspirators against his life, attorneys for Police Lieutenant Charles Becker, on trial here for the murder of Rosenthal, announced today that they would prove that Kraus was not on the scene when Rosenthal was killed.

"I saw a man walk out of the Metropolitan Hotel," Kraus testified yesterday, "and raise his hand to a level with his eyes. Instantly shots were fired and Rosenthal fell to the ground."

Kraus also swore that he recognized "Lefty Louie" Rosenberg, Harry Horowitz, alias "Gyp the Blood," and "Whitey" Lewis as three of the men who fired the fatal shots. He was not certain about "Dago Frank" Crofici being with the party.

Reports were current in the court room that "Lefty Louie" Rosenberg and "Dago Frank" Crofici alleged to have been implicated in the actual slaying of Rosenthal, were ready to confess. The reports could not be verified.

Thomas Ryan, taxicab driver, who assisted in the pursuit of the murderers, testified that one man did the shooting. This contradicts the testimony of Louis Kraus, the waiter, who swore that several shots fired by at least three men rang out simultaneously and Rosenthal dropped to the ground.

### SERVIA LATEST TO JOIN RANKS BELLIGERENTS

Berlin Receives Dispatch From Belgrade Announcing Declaration of War Against Turkey—Montenegrin Victories Confirmed.

Guerrilla Warfare in Progress Along Servian and Bulgarian Frontiers—Accusations of Looting Made.

BERLIN, Oct. 11.—Serbia declared war on Turkey at 4 o'clock this afternoon, according to an unconfirmed despatch just received here from Belgrade.

SEMLIN, Hungary, Oct. 11.—Confirmation of reported Montenegrin victories at Panitz and Ditchitch, in which Crown Prince Danilo of Montenegro led both assaults, was received here today. No verification was received, however, of the report that General Markinovich, the Montenegrin minister of war, had captured Scutari, in Albania.

Guerrilla warfare is in progress along the Servian and Bulgarian frontiers. The combatants charge each faction with perpetrating brutalities and with looting, burning and other outrages.

### STATE TAX TO PAY COUNTY OFFICIALS

SALEM, Ore., Oct. 11.—Legislators are today interesting themselves in a plan drawn up by Governor West whereby he would have a state salary tax to meet the salaries and expenses of the officials in all the 34 counties. The governor's scheme is to add one mill to every dollar due as taxes on the state assessed valuation of \$900,000,000. The total county salary and expense list is something like \$900,000 annually. The governor proposes to put a measure to this effect up to the next legislature. In his opinion it will prevent the political logrolling now said to be hampering the legislators in regard to the granting of small favors in the different counties.

### SUSPECTS NABBED FOR STORE ROBBERY

Police officers Cady and Megu made a ten-strike Thursday night by taking into custody Dave Martin, Jack Doan, and Dick Preston, who had in their possession much of the clothing stolen from the store of Faber & McDonald at Central Point Tuesday night. The three will be given a preliminary examination this afternoon in Justice Taylor's court.

The men were well supplied with tools to enter buildings, one of them having two well made skeleton keys for picking Yale locks. The officers noted the trio dressed in new clothes on Front street. They had just endeavored to sell three pairs of new gloves.

### CAPITAL PUNISHMENT RELIC OF BARBARISM

PHOENIX, Ariz., Oct. 11.—Characterizing capital punishment as a relic of barbarism and as on a par with the burning of witches Governor Hunt today reprimanded William Campbell, Eduardo Perez, N. B. Chavez, Miguel Porata, all of whom were to have been hanged today. The reprieves deferred the date of execution until April 13.

### GOMPERS' NAME IS DRAGGED INTO LABORITES' TRIAL

INDIANAPOLIS, Ind., Oct. 11.—The name of Samuel Gompers, president of the American Federation of Labor, was brought into the trial today of the forty-seven members of the International Association of Bridge and Structural Ironworkers, charged with illegally transporting dynamite, over strenuous objections of attorneys for the defense. This was effected by Federal District Attorney Charles W. Miller, when Frank Schilling, a St. Louis hotel clerk, was called to the stand.

United States Judge Anderson permitted Schilling to testify to an alleged meeting between Gompers and Olaf A. Tveinome of San Francisco in the Southern Hotel at St. Louis, November 27, 1908. United States Senator John W. Kern of Indianapolis, of counsel for the defense, objected to the introduction of this testimony, asserting that organized labor is not on trial here. The government met this argument by promising to show Gompers' connection with the defendants, and Kern's objection was over-ruled.

G. A. Dixon, a clerk in the Argonaut Hotel at San Francisco, testified that a man giving the name of J. B. Bryce registered there in 1910. He then identified a photograph of James B. McNamara as that of the man who had registered as "Bryce." George Hunter of Youngstown, a hotel clerk, testified that H. S. Hoeklin, one of the defendants, once registered at the hotel where he is employed.

### BOTH OLD PARTIES FIGHTING THE NEW

PHILADELPHIA, Oct. 11.—Proof that democratic and republican bosses have joined forces to besmirch Colonel Theodore Roosevelt, his running mate on the progressive national ticket was promised Pennsylvania voters here today by Hiram W. Johnson, California's fighting governor. Johnson came to Philadelphia to participate in the fight against Senator Boies Penrose, who, testifying before the senate campaign contributions investigating committee in Washington, charged that the Standard Oil company had contributed \$125,000 to the 1904 republican campaign with the knowledge and consent of Colonel Roosevelt.

### HEROIC FIGHT BY MESSENGER WITH BANDITS

FORT SMITH, Ark., Oct. 11.—While four masked bandits who boarded a northbound train on the Kansas City and Southern railroad at Hatfield, Ark., early today, smashed the glass in the express car door, Messenger Merrill Burgett opened the safes, hid the valuables and fired on the bandits from behind some trucks. One of the robbers was fatally wounded. The wounded man was picked up by another bandit, who jumped from the car with him. The two remaining outlaws finally smashed in the door and continued the fight.

Burgett's ammunition exhausted put up a hand to hand fight, but was beaten insensible. Unable to locate the treasure, the robbers tortured Burgett in an effort to force him to reveal the hiding place. When he still refused, the heroic messenger was again beaten into unconsciousness.

When the train reached Potter, Ark., the bandits cut the air hose, stopping the train, and vanished. Burgett is believed to be dying.

Posses have taken up the trail of the robbers.

### EDDIE'S PROSECUTION IS CONCLUDED TODAY

LOS ANGELES, Cal., Oct. 11.—Cross examination of Mrs. Alice Phelps in the case against City Prosecutor Guy Eddie is concluded today, under peremptory orders of Superior Judge Curtis H. Wilbur in the juvenile department here. After Attorney Earl Rogers had cross questioned Mrs. Phelps for five hours yesterday, fifteen minutes before the regular closing time of court Judge Wilbur ordered him to cease. Rogers took an exception to the ruling.

Assistant District Attorney Joseph Ford is expected to be the principal witness today. He will be called to show that Eddie promised to resign if not prosecuted on the charge of contributing to the delinquency of Mrs. Phelps, a minor.

### BRYAN IN MINNESOTA; IN DES MOINES TONIGHT

ST. PAUL, Minn., Oct. 11.—Leaving Grand Forks this morning Bryan invaded Minnesota and made several speeches. Bryan will leave for Des Moines tonight.

### HARRIMAN'S GIFT REWARDED BY SUIT DISMISSALS

LOS ANGELES, Oct. 11.—Attacking the statements made by Robert S. Lovett, head of the Harriman lines, before the senate campaign contributions investigating committee in Washington, Attorney Joseph H. Call, former special counsel for the United States government and a supporter of Woodrow Wilson for the presidency, in an interview here today declared that Lovett's testimony was "wholly unwarranted by the facts and untrue."

Call showed letters from the United States attorney general's office dismissing pending suits against the Southern Pacific railroad aimed to prevent a merger with the Central Pacific, a parallel line. The letters were dated in October, 1905.

Call claims that the suits were dissolved after the late E. H. Harriman had raised a fund of \$240,000 for the 1904 republican national campaign. He asserted that the dismissal of the suits meant millions of dollars to Harriman and his associates.

### STRIKE BREAKERS FOR UTAH MINES

BINGHAM, Utah, Oct. 11.—With hundreds of deputies acting as a bodyguard 100 strikebreakers are working the Utah Copper mine here today. With the exception of a few minor clashes between the strikers and deputies no serious trouble is reported.

Officials of the company announced that more strikebreakers would be employed at once. One thousand strikers held a big mass meeting and bitterly condemned the action of the deputies in handling strikers.

Charles H. Moyer, president of the Western Federation of Miners, and other labor leaders are conferring in Salt Lake to determine upon a course to be pursued against the company for using strikebreakers.

### EASTBOUND FREIGHT NEAR HUNTINGTON WRECKED

HUNTINGTON, Ore., Oct. 11.—A big wrecking crew is today clearing the tracks at Easton, Idaho, where freight train No. 56, eastbound, was wrecked. The track was torn up for some distance. No one was seriously injured.

### HOW TEDDY PRESENTED BOB DOUBLE-CROSS

Wisconsinite Flatly Charges That Roosevelt After Promising Support Undermined His Candidacy to Grab Nomination for Himself.

La Follette Put Out to Feel the Way and Pull Chestnuts Out of the Political Fire for Benefit of T. R.

MADISON, Wis., Oct. 11.—How Theodore Roosevelt is alleged to have urged him to make the progressive race for the presidential nomination and to have betrayed him, is told today by Senator Robert M. La Follette in his "The True Story of the Campaign," the second chapter of which appears in the current issue of La Follette's Weekly, just out. The Wisconsin senator flatly charges that Roosevelt undermined his candidacy for no other purpose than to grab the nomination for himself.

"On April 30," the article says, "a conference of progressives was held in Washington. They settled on me as their candidate and I agreed to make the race. Roosevelt had decided that the progressives should put forth a candidate against Taft. I entered upon the campaign with vigor in July, 1911.

"There was only one discordant note at this time among the progressives to my candidacy. James H. Garfield of Ohio, closest of all to Roosevelt, tried to prevent my endorsement.

"A little later, Col. Roosevelt in an editorial in the Outlook, referred to my endorsement: "The endorsement is to be regarded as a recommendation rather than a commitment of the movement to any one man."

Then, the article says, came a conference of Gifford Pinchot and others with Colonel Roosevelt, as a result of which Senator La Follette was informed that Roosevelt was not a candidate, though he would make no public announcement to that effect; that La Follette should go ahead, and if he could not win the nomination in the convention then Roosevelt might possibly step in as a candidate, but meantime "the wires should not be crossed."

"But," the story continues, "the wires seem to have got badly crossed."

### POISONED BANKER LED DUAL LIFE

PASCO, Wash., Oct. 11.—That Banker Christensen, for whose murder his young wife is on trial, supported "Bobbie" Rouchet, another woman, while living with his spouse, and otherwise lived a dual existence, is the evidence in the possession of the court today.

The Rouchet woman testified that she had demanded \$100 apiece from Mrs. Christensen for certain letters written to her by the dead man, but in lieu of the money accepted a proposition from Mrs. Christensen for transportation to Pasco and a home and clothing while testifying in behalf of her benefactor. She stated that while staying at the Christensen home, a vial of strychnine tablets were found in an old suitcase. Christensen came to his death through strychnine poisoning. The state has rested its case.

### MEXICANS THREATEN DEATH TO TRAIN CREWS

EL PASO, Texas, Oct. 11.—"All Americans operating trains in Mexico October 31 will be shot down." This is the ultimatum which is said to have been delivered to the officials of the North Western railway here today.

### DREXEL GAVE HUGE AMOUNTS TO REPUBLICANS

In 1904 Campaign, Raised \$165,785, for State Purposes and \$50,000 for Roosevelt's Fund—in 1908 Gave \$100,000 and \$25,000 for Taft 1912

Receipts of Chicago Office of G. O. P. Four Years Ago Totalled \$548,320—Illinois Primary cost \$36,000

WASHINGTON, Oct. 11.—Sworn testimony that his firm contributed heavily to the campaigns headed by Colonel Theodore Roosevelt and President Taft was given before the senate contributions investigating committee here today by E. T. Stotesbury, head of the Drexel Banking company, one of the strongest financial institutions of Philadelphia.

In 1904, when Roosevelt was the republican nominee, Stotesbury declared he raised a fund of \$165,785 for the fight in Pennsylvania. Then, in 1908, he said, when President Taft headed the ticket, he contributed \$100,000. The witness also declared that he contributed \$25,000 for use in the present republican campaign.

Stotesbury said that in 1908 his company contributed \$50,000 to the Roosevelt fund; the United States Steel Corporation gave \$12,500 and other steel interests \$23,000.

After the examination of a number of minor witnesses, Frederick Upham, assistant republican national treasurer in 1908, submitted his records. He testified that the receipts of the Chicago headquarters were \$548,320.

Frank Smith, internal revenue collector of Springfield, Ill., who was manager of the Taft pre-convention campaign in that state, testified that he spent \$28,000. He did not know of any other expenditures. He declared he had refused all contributions from federal employees.

### KNOX AND FISHER BACK FROM ORIENT

SEATTLE, Wash., Oct. 11.—The armored Cruiser Maryland arrived in port early this morning from Japan, with Secretary of State Philander C. Knox and Secretary of the Interior Walter L. Fisher on board. Secretary Knox is returning from Japan, where he represented the United States at the Mikado's funeral.

The cabinet officers were welcomed by a delegation of Seattle citizens and escorted to a hotel. This morning they are on an automobile tour about the city.

Secretary Knox may decide to stay here to address a republican meeting Monday evening. Secretary Fisher leaves for the east tomorrow. He has spent several weeks in government work in Hawaii.

### JOHNSON TO MAKE THREE OREGON SPEECHES

PORTLAND, Ore., Oct. 11.—Definite assurances are today on hand that Governor Hiram Johnson of California, bull moose candidate for vice-president, will make three speeches in Oregon, urging the election of the bull moose ticket, the latter part of this month.

One of the speeches will be made in Portland. The Portland headquarters of the third party is trying to arrange the date, and toward this end, is in communication with A. E. Clark, the new party's candidate for senator. Clark is being kept fully advised of Johnson's movements.
