PRESS PROSECUTION OF BOGUS RINGLING

PORTLAND, Ore., Nov. 16.—The police are today in receipt of a request to press the prosecution of John E. Hudson, alias John E. Ringling brothers of circus fame, in behalf of the circus. With the aid of the local Pinkerton office the police are, by piecing together the meteoric career of the debonaire young man, who is incarcerated for trying to "touch" a Portland banker for \$1,000, without collateral. Among Hudson's effects were found several letters written on Ringling brothers' stationery to the alleged swindler by Al Ringling, a member of the circus firm, in which the youth's engagement to a Miss Beadle Hayes of San Francisco is deplored.

MRS. LISTER RECEIVES CONGRATULATIONS FROM WEST

TACOMA, Wn., Nov. 16.—Mrs. Ernest Lister, wife of the governor-elect of Washington, is today in possession of a telegram from Governor West of Oregon, congratulating her upon being the first lady in Washington. Governor West and Mrs. Lister, then Alma Thornton, attended Salem schools together over a score years ago. When West was elected Mrs. Lister was one of the first to congratulate him.

NEARLY \$8000 SPENT IN FIGHTING SUFFRAGE

SALEM, Ore., Nov. 16.—Expense statements filed today with the secretary of state by Wallace McCannan of Portland, show that he expended \$443.40 against the woman suffrage amendment and that Catherine McCannan, treasurer of the Oregon State Association, opposed to the extension of suffrage among women, expended \$5213.40. The statement filed by the College Equal Suffrage Association, of Portland, shows it expended \$2716.41 in favor of the amendment.

ROSEBURG, Or., Nov. 16.—Robert L. Mooney, an ex-convict, who last summer induced an Oakland girl to run away with him, and who after keeping her a week in Astoria, was found guilty on the white slave charge by a jury in the circuit court here, and was this morning sentenced to the penitentiary by Judge Hamilton to serve an indeterminate sentence of from one to five years. He will be taken to Salem and placed in the penitentiary tomorrow.
