10,000 Turks Surrender

SOFIA, Nov. 29 .- It was officially announced here today that two entire divisions of Turkish reserves, numbering 10,000 men, had surrendered to a Balgarian force near the village of Marhamli. Eight mountain hatteries also were taken.

At Williams' request the warden last night assembled the prison orchestra about the death chamber. They started playing at 9 o'clock and continued to play hymns and other airs until midnight.



WRITER OF POST CARD CONFESSES TO MANIACAL MURDERS OF SEVERAL CHILDREN TYPHOON SLAYS

Two Cities Practically Destroyed and Immense Damage Done-Half the Population Slain-Wires Down and Details of Disaster Meagre.

Relief Stores Rushed From Manila-Adjoining Territory Swept Last

WASHINGTON, Nov. 29 .- That 10,000 to 15,000 persons probably were killed and injured in the typhoon that swept the Philippine Islands last Tuesday, is declared in cable despatches received today by the burean of insular affairs.

WASHINGTON, Nov. 29 .- Despatches received by the state orpartment here today confirm the report of the destructive typhoon which occurred in the Philippine Islands.

The town of Tecloban, the capital of Leyte, was practically destroyed. Enormous fatalities occurred at Capiz, the capital of the province of Capiz, but no details were given. Leyte has a population of 14,000

and Capiz 20,000. The news of the typhoon was cabled to Washington by the governor general of the Philippines. No estimate of the number of dead and injured was given, but it was stated that probably half the population of both the towns of Taciobas and Capiz met death.

The governor general's despatch was sent yesterday. It was stated a shipload of food, clothing and medical supplies is being rushed to Taclo-

All wire communication is disrupted and only vague reports are obtainable. The stricken territory is just north of the scene where many were killed by a typhoon October 15 last. The Red Cross is joining the
