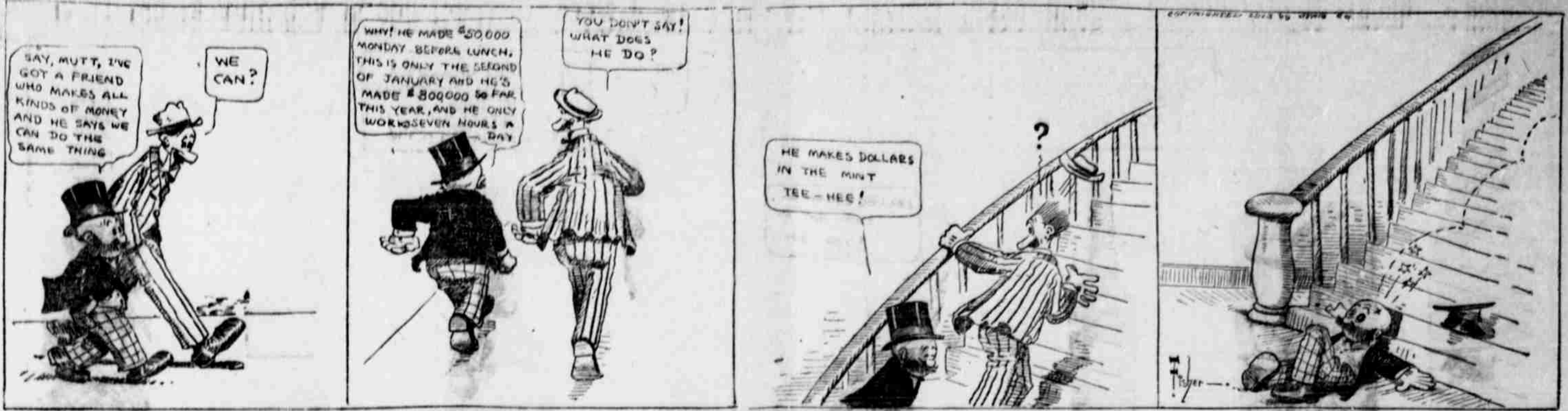

What the effect of the cold snap in California will have on fruit prices and ranch sales is being discussed by those vitally interested. I believe in the strict enforcement of law, and any police officer, who fails or neglects to do his duty should be removed.
