

### COUNTY TO PAY \$4200 EXTRA ON BEAR CREEK BRIDGE

Following a conference with the city officials the county court has announced that they will pay at once the balance of \$4200 due the contractor for "extras" in the construction of the bridge. The city and Pacific & Eastern have paid the \$16,500 according to their agreement with the county, and this payment under the decision of the supreme court will allow the county to make payments in excess of the \$18,000 contracted. In its decision the supreme court said: "According to the plain provision \* \* \* it is incumbent upon the county of Jackson to build, maintain and repair all bridges and culverts upon county roads in the city and road district. \* \* \*

"The decree of the lower court will therefore be modified so as to restrain the \* \* \* payment of any county warrants on account of the bridge contract in excess of \$18,000 until such time as the city of Medford and the P. & E. shall have paid into the treasury of Jackson county \$16,000 as per agreement."

The extras are due to certain changes in the plans ordered by William Gerig, consulting engineer retained by the county. The principal change was an increase in a retaining wall to make it stronger.

### GOVERNOR BLAMES CROOKED REPORTER

SALEM, Ore., Feb. 5.—To the "crookedness of a certain newspaper reporter," and not to rumors that have gained currency through any other source, Governor West attributes the report that has gone abroad that he is party to a political frame-up that would put George E. Chamberlain into the Wilson cabinet, give West the senatorial toga, and Secretary of State Olcott the combined offices of secretary and governor.

Said Governor West today: "The report that has gone out about a political combination to which Senator Chamberlain, Secretary Olcott and myself are parties is a product of the disordered mind possessed by a certain crooked newspaper reporter. "I am for J. N. Teal for secretary of the interior, and for George E. Chamberlain for United States senator. But, of by any good fortune it should happen that Senator Chamberlain should be named for a position in the cabinet of President Wilson, I would be very much pleased, and by reason of the vacancy in the senate caused by such an appointment, I would feel it my duty, and it would afford me great pleasure to appoint some clean, honest democrat to succeed him. I am having too much fun here at present to have any desire to go to the senate. Neither the secretary of state nor myself are so hungry for political honors as to enter into any such scheme as that outlined in the newspaper report. I will say further that I am not a candidate for reelection for governor."

KLAMATH FALLS, Feb. 6.—W. L. Clapp of this city, and his party, who left for Crater Lake last week, returned to Fort Klamath last night. The party was successful in securing several fine pictures, which was the principal thing its members were after.
